GOD AND RACES - PART 2

This message was preached by Brother Amos, on the morning of Sunday, 16th November, 2014, at the November 2014 Convention, at Bible Faith Tabernacle, Lagos, Nigeria. It is the very informative second part of this three part message, which gives us great insight into what has taken place in this world, to make it the horrid place that it has become. It is perfect revelation!

I greet everyone in Jesus' name. We trust that you had a restful night. And may the blessings of the Lord rest mightily upon you. It has been a long journey, but this is the last lap of the journey, and we will see Jesus Christ very soon, for he is coming very soon. However before he returns for his bride, the Lord is going to come in the Excellency of His glory and power, to

empower and to beautify His people that have stood for His truth, and that are not ashamed of his testimony, the testimony of his Word of life. I have a lot of ground to cover this morning, and I pray that God will help me.

Shall we turn our Bibles to the Book of Genesis Chapter 1, and from verse 11, it declares: ***"And God said, Let the earth bring forth grass, the herb yielding seed, and the fruit tree yielding fruit after his kind, whose seed is in itself, upon the earth: and it was so. And the earth brought forth grass, and herb yielding seed after his kind, and the tree yielding fruit, whose seed was in itself, after his kind: and God saw that it was good."*** Every living thing God made, He gave it the ability to reproduce itself, and



They reproduce strictly after their kind. They do not reproduce contrary to their kind, but strictly after their own kind. There is no ability given to any living creature of God to reproduce contrary to their kind, for that would be contrary to nature, and more importantly, it would be contrary to the infallible and unchanging law of reproduction which God established to govern reproduction, ALL REPRODUCTION, be it natural or spiritual, for the law of reproduction is one. It is a fundamental law, and it is most infallible and immutable, that EVERY SEED SHOULD BRING FORTH AFTER HIS KIND. This law holds, whether we think in terms of common bugs, or even bacteria, or plants, or fishes, or birds, or animals, it is impossible for them to bring forth contrary to their kind. Yesterday night, we ended with the consideration of the lower species of God's creation. We took a look at plants, fishes in the sea, birds of the air, and the animals in the field. This morning, we want to continue from right there. Brothers and sisters, look at the primates, the ape family. You have the gorilla in that family; you have the chimpanzee in

that family; you have the baboon also in that family; you have the monkey, and you also have the orangutan, all in the same family. Are you with me? So we see that quite a number of animals make up the ape family, but yet, they are all different species of apes. We all know that animals only mate strictly for the sake of reproduction, and that is at their mating season, their seasons of reproduction. Saints, it is a notorious fact that you will never get a baboon to mate with a monkey. You are not going to get an Orangutan to mate with a gorilla, and neither will you get a chimpanzee to mate with a baboon. Yet they are all one family, the family of apes, the family of the primates. It is just like the family of cats, which gives us the lion, the leopard, the tiger, the cheetah, the jaguar, the cougar, the domestic cat, and so on. They are all one family, the cat family. But nevertheless, none of them can cross-breed, because of God's unchanging and infallible law of the reproduction of seeds. Man is the only reason why we have cross-bred animals on this planet. They are the ones that are responsible for the hybrid creatures we have today on the planet,

for they have created a lot of hybrid animals: They have bred the lion with the tiger; they have bred a goat with a sheep, (and the head of it is like the head of a goat with two horns, but the body is the body of a sheep); they have bred a tiger with a leopard. I want you to understand this morning, as the bride of Jesus Christ, that that is nothing but the operation of Satan, for it is demonic! I said it is demonic! Look at the various hybrid birds and hybrid dogs men have created. They have also done this with various plants, and they have created flowers which are nothing but hybrids, though they may look beautiful. That is also why, for instance, they have created this stunted plant tree which the Japanese call *Bonsai Tree*. They touched the genes of that plant and stunted it, just because of its beauty. By manipulating the genes, they made a big plant tree grow so small, and it remains like that all its life, which is why it remains forever in a little pot, as a little tree! That is a tree that rich people love to have, to put in their living rooms, and it is expensive! All those things are nothing but operations of Satan.

And as the bride of Christ, it is crucial at this point in time to understand the mind of the Spirit of God concerning the things we are talking about today, for some people have to see right, particularly as gross spiritual darkness has taken over the world! However, before I move on with my message, let me resound a note of warning I gave yesterday. I will say it this way: The issue of interracial marriage does not touch the salvation of the souls of men. Let us understand that now. The issue of interracial marriage does not take away the salvation of anybody's soul. It is not an issue that touches salvation, neither is it an issue that denies salvation to any man, because every last one of us was born in iniquity; we were shaped in sin, because we all had a fallen birth, being sinners by birth. So from birth, we are children who deserve to go to hell, but grace, nothing but the sovereign grace of God expressed in Christ Jesus, is what caught us at God's appointed time, and made the difference in our lives, saving our souls. God said: *"In spite of your terrible fallen state, and however bad it is, you are mine, and*

as such, I redeem you back to myself through my Son, Jesus Christ." This is so, because salvation or redemption is strictly of God, and hence, it is a gift which we receive by faith in the finished work of Calvary. Therefore, the message of redemption says, *"COME AS YOU ARE. LOOK AND LIVE!"* In other words: ONLY BELIEVE! That is the requirement, and salvation is yours, regardless of how bad your life may have been: Because there is no man whose life is worthy of salvation, for as it is written, If the Lord should mark iniquity, who can stand? Consequently, I want it to be fully understood, that there is nothing in what I am preaching today that touches the salvation of people who are products of mixed marriages. I repeat: There is nothing I preach today that takes away the salvation of people that are products of mixed marriages, because salvation is of God, and we are saved only by the grace of God. That is a fact! Only believe! However, as bride saints, as children of God who have been brought into the true light, particularly ones living at this very end of the end time, we want to know the

mind of our Father concerning creation, and we also want to walk with Him in that light, bearing the understanding of His perfect will; because in days of ignorance God winks, for we do not know better. But when God sheds His light upon His Word, as a child of light, He expects you to walk in that light; He expects you to use the revelation of His Word to guide your decision in choosing a spouse, that Satan may not ensnare you. This is a fact, for you should be able to see the operations of the devil, for as it is written: We are not unaware of the wiles of the enemy! So brothers and sisters, I warn again, just like I warned yesterday: I do not preach this as an offence to any mixed race people, because I have nothing to boast of in my own self; because in myself, I am nothing; just a sinner saved by grace. And the difference between you and me is that I am the worst sinner God has ever saved. That is the only difference between you and me; the fact that I am worse than you, but that God's grace and mercy found me, and brought me out. That is my testimony; that is my story! I am a trophy of God's mercy,

longsuffering, goodness and love; for He picked me, one who is not worthy to be a minister of the Gospel, up from the gutters of sin, and He made me, not just a minister of His Word, but one to carry the light of Jesus Christ for the bride of Christ universal. But what can you do with the sovereignty of God? He said, "*Jacob I love, and Esau I hate. I will love whom I will love.*" What are you going to do with that? It is just the grace of God. I say all that to let you know that I am not better than anybody else, and as such, it is not possible for me to condemn anybody with this message. And I certainly do not preach this to condemn any mixed race person. However, I owe God and His people a responsibility to answer the questions of God's children, and to show them the perfect mind of the Spirit of God concerning mixed marriages, or concerning interracial marriages. And I will say this morning, just like I said yesterday, that there has to be a truth concerning this matter in the Holy Bible; there has to be truth concerning this issue, but as it is written, it is for the wise to search it out. And as it is also written: We are the wise of the end

time, the people whom the Lord promised shall understand! Consequently, as I declared yesterday, and by the grace of God, I declare this morning, I have the answer to this question. That is why we are preaching this. But I only pray that God will give me grace and the inspiration, the divine unction, to lay it forth in a way that will make everything plain, for the edification of the body of God's elect people all over the globe. And having done that, having done my part, the rest remains with you, for what you do with it is between you and God. But at least, let it be said that I have shown you the right way, although I pray you follow that right way. Amen.

Brothers and sisters, when we look at the mongrelizing of God's creation which is going on today in the earth, you must know that it is not of God. It never has been of God! But you will tell me that certain species evolved from other species. To that I will promptly reply that those things happen according to the law of mutation God placed in His own creation, as Creator, and according to God's timing and leadership, in order to bring variety to the species.

Period! So it is God doing that, for He alone is the Creator, and as such, no man has the right to mess with God's creation without paying a price. He certainly will! Brothers and sisters, the devil cannot create anything, except to pervert what God has created, and because he cannot create anything, is precisely why he had to use the Serpent creature to get seed to himself vicariously (indirectly), an offspring called Cain, and we will still come back to consider this offspring. Saints, Almighty God alone is Creator, and the God of all creation established a law at the very beginning, a law recorded at the opening of the Seed Chapter of the Holy Bible, a law of reproduction, one that will never change, regardless of what the devil inspires men to do in the earth, and that is that **EVERY SEED IS TO BRING FORTH AFTER HIS KIND!** This law will never change nor be overridden, though men may mess with it, as inspired by the spirit by Satan; but the mind of God, the will of the most High God, still stands infallible and inviolate: Every seed is to bring forth after his own kind, because we are not all of the same kind, for God

created everything in variety. All plants are not the same, for they are in super abundant variety, and every variety or species maintains its particular and original stock, through the process of reproduction of seeds, thereby keeping its originality. All fishes are not the same, for they are in super abundant variety, and every variety or species also maintains its particular stock, through the process of the reproduction of seeds, keeping its originality. All birds are not the same, for they also have an incredibly large variety, being over abundant, and every variety or species also maintains its particular stock, again through the process of the reproduction of seeds, keeping its originality. So also, all animals are not the same, for God created them in astonishingly abundant variety, and every variety or species, also maintains its particular stock, again through the process of the reproduction of seeds, thereby keeping its originality, keeping its original estate. So likewise, all men are not the same, for Almighty God has also made us in great beautiful variety, being the crown of

His natural living creation. However, it is only man that is out of sync. It is only man who has not maintained his particular stock, genetic stock, which is a racial stock, for he has not kept his originality, and this he has done through interracial marriages, cross-breeding himself, coming together in a union, specifically and solely for the reproduction of seeds, original seeds, contrary to what God ordained! The undeniable truth is that God is a God of variety, and He loves variety, which is why He made and makes variety in everything that He creates, beginning with bugs and microbes, (bacteria), plants and flowers, aquatic creatures, like fishes and lobsters, birds, animals, and man. Even the angels were created in variety, though they are spirit beings! Think about it! It is purely because our Creator, Almighty God, is a God of variety, and He loves variety, and He has created incredible, extremely enormous, mind boggling, and complex variety in this universe. His awesome majesty, glory, and creative power, is expressed in the incredible variety of living things that He has made, creatures which are the

works of His hand. Hence it is written in Psalm 19, verses 1-4: ***“The heavens declare the glory of God; and the firmament sheweth his handywork. Day unto day uttereth speech, and night unto night sheweth knowledge. There is no speech nor language, where their voice is not heard. Their line is gone out through all the earth, and their words to the end of the world. In them hath he set a tabernacle for the sun.”*** Church, if you are to understand anything about God, it is that God is a God of variety; Not the variety that man has made under Satan, but a variety God Himself initiates, that it may serve His divine purpose, the purpose for which He alone created this whole universe. You have got to understand that! Brothers and sisters, William Branham, the Elijah-Star messenger to this Laodicean age, has something to say concerning this matter, and I am going to read his quote to you. But before I read his quote, I first want to make reference to an email I received from one brother in the United States, at the end of July 2008, about our book titled, *The Input of Ham*. This was before the

issue of "Religo" developed. He is a follower of Richard Gan of Singapore, and this is what he wrote, and I quote him only in material parts: **"Greetings Brother in the Name of our Lord Jesus Christ. I was just sent your web address by my beloved Brother Richard Gan, and I have finished reading your book, "The Input of Ham". It thrilled me Brother, and I rejoice in what God is doing with and through the lineage of Ham. I trust all is well with you and yours and the blessings of the Most High continue with you. When I first met Brother Gan there was much in the way of prejudice against his race which also proceeds out of the genre of Ham... Another thing Brother I disagree with you about is intermarriage. Paul the Apostle never considered race in the Body of the Christ. I realize the natural view and see the continuity of your thoughts, however, Paul placed no value on the three races as distinct, and he did not forbid marriage within Christ on any such basis. In fact, the only stipulation he gave was to MARRY IN THE LORD.**

To my way of thinking presently, Paul never classified Gentiles except apart from Israel. All apart from Israel were the Gentiles, and they and Israel are ONE NEW MAN IN CHRIST. You touched upon this in your message and did a very good job, but you were unwittingly destroying your stand against interracial marriages. These are my observations Brother and I voice them to you from Tucson, AZ." First, let me say that because of the importance of that message, *THE INPUT OF HAM*, which is in book form, we decided to take it and lay it in the Scribe, because the Scribe Magazine is the main means that God is using to carry the Continuity light of His Word around the globe. Consequently, we now have a Scribe titled, *The Input of Ham*. It will be distributed this morning, for it is ready. By the grace of God, nine Scribes will be ready for distribution today, and we bless the name of the Lord for it, and we want to appreciate the support of the saints, and the sacrifice of the saints, that made all these things possible. Our payday is coming up there in glory. Coming back to the

brother's email, I wrote him back to appreciate his nice letter. But concerning the issue of mixed marriages, I let him know that it is the mind of the Spirit of God that I laid out in the book, and I also tried to show him one or two things, and I let it go. He replied me, disagreeing with the things I wrote, and I simply did not bother responding to his reply, for it would serve no useful purpose, only becoming like ping-pong, (going back and forth). Although we pray that people see the truth, the fact remains that you cannot make anyone see anything, unless the Lord is also dealing with them by His Spirit. After all, we are at liberty to believe whatever we want. I do not waste my time arguing with people on issues of life. You can call me any name you want to, it cannot stick on me, and I do not care for names. By the grace of God, as long as I know where I stand in the light of truth, I do not care for anything else; I do not care for what people think or say. This morning, I am trusting God to help me to show you precisely the mind of God, because you must understand that when we come to the issue of interracial marriages, I will tell you plainly and clearly

that it is DEFINITELY not of God, and God does not want it. It nullifies the first principle of reproduction, one which is a fundamental law guiding ALL REPRODUCTION, which is that EVERY SEED MUST BRING FORTH AFTER HIS OWN KIND. Consequently, we cannot go by the brotherhood of man, (the universality of man), in this regard, because we are not the only universal species God has placed on this planet under the law of reproduction! The law applies to all natural living creatures, without any exception! And this is precisely where it affects the issue of marriages! Plants, just like fishes, birds, and animals, are also of one family, the family of birds, and yet, the hibiscus flower in its natural process of reproduction or pollination, will not crossbreed with the daffodil flower, just because they are all one family of flowers; the reason being that the daffodil is a different specie of flower to hibiscus! That is why! For every seed is expected by God to bring forth after his kind, and the only way to do this is for each specie of flower to pollinate its fellow species!

Period! And that precisely, is how it operates till this very day in the plant kingdom, except where men have tampered with the law of God! Fishes also do not interbreed just because they are all fishes, but they breed solely after their own species, for the herring fish, for instance, will not breed with the sturgeon or with the sardine, all because they are all part of the fish family! We can say the same thing of birds, for an eagle will not mate with a hawk, for instance, on the premise that they are all of the family of birds! And neither will a monkey mate with a baboon, on the flimsy premise that they all belong to the same family of primates, not to even talk about Primates mating with cats, just because they are all animals! Come on! You know that that is impossible! What is wrong with man? Yet, the law of reproduction remains the same, being eternally unchangeable and infallible, for God does not produce freaks and hybrids, but only original creatures, creatures which He endows with the power of self-reproduction, guided by the law of the reproduction of seeds! What is so difficult to see in

that, if the hearts of men were right, and if they were not set in their ways? Now, I will read Brother Branham's quote on this issue, and also follow it up with the position of the chief apostle, Raymond Jackson, on the same matter, for God used him to deal with this subject, not as a message in itself; but he touched on it in the course of his messages. So we do have quotes here and there on this issue. Also Brother Branham did not really preach on it, but he likewise touched on it, for he certainly made his opinion known here and there, and we also have his quote on the matter. However, I wish to point out that because of these quotes, because of the stand which Brother Branham and Brother Jackson took on the issue of interracial marriages, they have both been accused of being racists. At one time after the death of Brother Jackson, I was in the United States in the house of a pastor supposedly following Brother Branham and Brother Jackson, in the light of the Word they bore for the universal body of God's people. I had been to his church a few times before this home visit. And

because there were things that were going on in his church that were not right, apart from the fact that they were inherently organizational, as opposed to an End Time Message believing church, I felt that I would be a great hypocrite to come all the way from Nigeria to be a blessing to his church, and not tell him IN PRIVATE, about those things that were scripturally out of order. God expects me to be sincere and faithful, as a true brother. It was not even a rebuke. I was only trying to show him that certain things that were being carried on in his church fell short of acceptable scriptural standard. He is the pastor of the church in New Jersey, where Brother Wilbur Jordan came out from. And because that pastor has a hearing problem, I asked that his wife be there to tell him what I was saying, and I also asked my wife to be there as my own witness. As I began to lay out my observations, that he may see the truth and bring about the desired change in his local assembly, he argued over everything, and I realized that there was no point. But at least I had been faithful to him; at least I had not played the

hypocrite, and I had been sincere, for by the grace of God, I did not see the truth of things affecting his assembly, and then just shy away from telling him. So I knew that having done my part, my hands were free of his blood, and that whatever he did with what had been shown him, was between him and God. But in the course of our discussion that day, because we touched on the issue of interracial marriages, and because one of his own sons is married to a white lady, the man accused Brother Branham of being a racist, and he also accused Brother Jackson of being a racist. This let me know that after I later separated from his assembly on account of truth, I would also be accused of being a racist. I have to say that, because if he could call Brother Branham and Brother Jackson, the two men that he said he was following, racists, is it me who he is not following that he would not call a racist, when I believe exactly the same thing? How many see my point? That was why I said that I am not a racist. I love the brotherhood; I love the people of God; and I do not care for any skin colour. We may have the barrier of

language and language accents right now, but we love one another in the Lord, and I do not care for colour, and that is the truth! However, church, you are not going to take away from what God has set in order, regardless of your feelings. So if telling you the truth of the mind of God concerning interracial marriages makes me a racist, then let me be a racist, even though I am not one. I know that I have not behaved badly or strangely towards any man on account of his colour, and the Lord is my judge. But the truth is, whatever colour you are, if you trample upon the Word of God, I will not care for your colour, and I will tell you straight that you are out of scriptural order, for there is no respecter of persons with God. Simple! That was the problem I had with the white folks at Faith Assembly. Some of them would not even shake your hand because you are black! That is how much hate they hold in their hearts for God's people of colour! And because God gave me the boldness, the love, and the sincerity of heart to tell them some bitter truths in the church of East Chicago, truth that they needed a pastor, and that they should pray for

one, then they climbed their pulpit in East Chicago, saying: **"How dare that black man from Africa come tell us what to do?!"** Because of truth, I then became a black man from Africa! But then, am I not a black man? I am the Lord's black man, the Lord's black man from Africa, and I am proud of it. Glory be to God! Amen! And where is the church now, that church in East Chicago? It has collapsed, and ceased to exist, for no one can kick against the pricks and not pay a price! In Proverbs Chapter 8, concerning the cry of wisdom in verses 33-36, it is written: **"Hear instruction, and be wise, and refuse it not. Blessed is the man that heareth me, watching daily at my gates, waiting at the posts of my doors. For whoso findeth me findeth life, and shall obtain favour of the Lord. But he that sinneth against me wrongeth his own soul: all they that hate me love death."** That is the truth! God in His own Omniscient mind and sovereign grace; God in His unlimited intelligence, and in the Excellency of His infinite wisdom, decided in Himself: **"This seed of mine called Amos, he will be**

black and beautiful, for he is my African servant." Halleluiah! I am proud of who I am in Christ, for in Christ Jesus, I am black and beautiful! If anybody has a problem with that, that problem is all yours. I do not care for your racial colour either! Get one thing straight: You will not make me bow down on issues of truth, on account of colour or race. I will not bow down to any man on this planet, for I know exactly who I am in Christ, and there is no man in any part of this globe, who will come and tell me anything about the Scriptures! I will walk tall with my Lord in His light! And I will look at you, whatever your colour or race may be, and regardless of who you are, and I will ask you just one simple question. (Brother Amos bursts out singing):

Are you walking? Are you talking?
Are you walking and talking with the Lord?
Are you travelling in His light
Every day and every night?
Are you walking and talking with the Lord?"
Because,

I am walking, I am talking
I am walking and talking with the Lord.
I am travelling in His light
Every day and every night.
I am walking and talking with the Lord

We are walking, we are talking;
We are walking and talking with the Lord
We are travelling in His light
Every day and every night.
We are walking and talking with the Lord.

When Brother Branham was preaching on *The Seven Seals* in 1963, he had a question and answer session on the morning of the last day. In the fourth question, he was asked concerning interracial marriages, and listen to the firm and categorical stand of the end time Elijah on this issue. The prophet replied: **"And I've said from this pulpit... We have lots of coloured people"**, (black people, coloured being an American term in those days used to distinguish black folks from the Caucasians, who are white), **"that come here. (I don't think there's any here tonight.) But we have lots of coloured people that come here to this church. Brother, they're as welcome as anybody else is. They're my brother and sister. And some of the finest people I ever met in my life is some of them coloured people. Then there's some of them that's renegades, just exactly like the white people, or the yellow people, or the brown people. Yes, indeed. NOW, I DON'T BELIEVE IN MIXING MARRIAGES."** (Did you hear that? He

continued): **"I believe that a white man should NOT marry a coloured girl, or a coloured girl marry a white man, or a yellow marry a coloured or a white..."** (Now listen to this, for the prophet now talks of God's human variety, God's racial garden): **"I believe the brown, black, white, and other races of people are like a flower garden of God, and I DO NOT BELIEVE THEY SHOULD BE CROSSED UP. I believe that's the way God made them, and I believe that's the way they should remain. What... It fools me that I seen some real pretty coloured girl, intelligent, nice looking kid, just as pretty as any woman you'd want to see... What does she want to marry a white man for, and have mulatto children? Why would an intelligent coloured girl want with such a thing as that? It's because that something"** (is influencing or motivating her). **"And why would a fine coloured man want to marry a white woman, and have mulatto children? I don't believe"** (in mixed marriages). **"I BELIEVE YOU SHOULD STAY JUST WHAT WE ARE. We're servants of**

Christ. And God made me... If He made me, my color black, I'd be happy to be a black man for God. If He made me yellow, I'd be a happy yellow man for Christ. If He made me white, I'd be a happy white man for Christ. If He made me brown, or red, an Indian, whatever it is, I'd stay my same color. That would be me. I WANT TO BE LIKE MY MAKER MADE ME. [Genesis 1:11-12]" That is the scriptural stand of the Star messenger of Jesus Christ to this last age, and he based it squarely and firmly on Genesis Chapter 1, verses 11-12, which he used to support his statement of claim! Chew on that! He declared plainly and categorically that a black sister should not marry a white brother, and a white sister should not marry a black brother, and vice-versa! He plainly stated: **"NOW, I DON'T BELIEVE IN MIXING MARRIAGES. I believe that a white man should NOT marry a coloured girl, or a coloured girl marry a white man, or a yellow marry a coloured or a white... I believe the brown, black, white, and other races of people are like a flower garden of**

God, and I DO NOT BELIEVE THEY SHOULD BE CROSSED UP. I believe that's the way God made them, and I believe that's the way they should remain." He gave the precise reason declaring here in this quote, saying that **"... RACES OF PEOPLE ARE LIKE A FLOWER GARDEN OF GOD."** That is a very serious and most insightful statement, that the varieties of people, whether Chinese, Indians, Malaysians, Europeans, Jews, Algerians, Nigerians, or whatever it is, are like a flower garden of God. That is a simple statement, but one that is very deep! Brother Branham was using the incredible variety and beauty which exists in the flower plant kingdom to exemplify the variety and beauty that also exists in God's human creation, God's human flower garden! As there are diverse species of plants and flowers, with their different colours, different sizes, different shapes, and different grades of beauty and scent, so is God's human flower garden. That is why humanity is full of racial variety or diversity, all expressing and revealing the glory of the God of variety, and we are going to

zero in on this most perverted teaching, which justifies interracial marriages, for it tears down the beauty of God's human flower garden. Therefore, brothers and sisters, if we are truly the flower garden of God, His human flower garden, and an unchanging law of reproduction has already been spoken into effect in Genesis Chapter 1, verses 11-12, that every seed should bring forth after his kind, in order to sustain and maintain this flower garden, common sense will let you know, therefore, that that law is also speaking to man, for it also applies to God's human flower garden. It is not suspended for man, for the law is all encompassing, ruling all natural reproductions! Exactly! That is precisely why Brother Branham said that he does not believe that they should be crossed up, for that destroys God's beautiful racial variety, God's human flower garden, and he quoted Genesis Chapter 1, verses 11-12 as his authority! And how else can we keep that from happening, except and only except every seed brings forth after his kind by Non-Interracial Marriage! Exactly! In other words, God's beautiful and diverse

human flower garden can only be sustained by marrying into one's own genetic race! Full stop! This firm stand of Brother Branham is exactly why people out there call him a racist. People who also say that they follow him also call him a racist, simply because they have a rebellious spirit in them, and they cannot be taught anything that conflicts with their fleshly desires! Just how can people claim to believe and follow Brother Branham in his light, and reject such a serious and scriptural presentation of truth? Come on! How can a follower of the prophet agree to Interracial Marriage? Brothers and sisters, let me tell you that in all creation, Man is the only species that God has this problem with. As we showed earlier, every other living creation of God on this planet keeps the original order of God: All bugs and birds keep the original order of God for reproduction; all fishes keep the original order of God for reproduction; all birds keep the original order of God for reproduction; and the animals maintain the same original divine order. Only man cannot be made to subject himself to God's

original divine order, because he is the only fallen natural creature! And that is precisely why they always have, and continuously will mongrelize themselves, ever producing more hybrids upon this earth, more than anything else that exists on God's green planet. They are also the ones that are creating the hybrids in all God's creatures! Let me tell you now, if time should tarry, it would come to a point where there would no longer be any races again on this earth, I mean distinct races. Everything would have been fouled up, totally mixed up! The volume or the number of children of mixed marriages, and the population of mixed marriage couples, are growing around the earth, so much so that, if time should tarry, the distinct races will disappear completely; because that is the devil's objective! Saints of God, I want to show you something this morning, why we should not touch these things, because we are the bride of Jesus Christ, and we have the mind of the Spirit of God. We know the will of our Master, because God does not leave His people in

darkness; but rather, He gives us the revelation of life. Halleluiah! In that message, Brother Branham called the push for mixed marriages communism, saying that communism is trying to water down God's plan. But we all know that it is more than communism that is responsible for this horrible development; it is just the dirty devil wanting to bring about a breakdown of human society, just to destroy God's human flower garden. Brothers and sisters, I will show you why you cannot go down that road, and what the objective of Lucifer is, in wanting to bring about the breakdown of human society in their racial content. I will show you this morning by the grace of God. I am not ashamed or afraid to declare before the whole wide world, that I stand firmly and unshakably with Brother Branham in the position he took, for that is also where I stand. And although he said that that was his opinion, I will remind you that his opinion is anchored solidly in the true revelation of the Scriptures, for he saw the spirit of Genesis Chapter 1, verses 11-12, an unchangeable fundamental law governing

the reproduction of seeds, requiring that every seed must bring forth after his kind. And in order for them to be able to do just that, is why when God made a male of a particular species, He made sure that He also made a female of that same species, so that they can reproduce their kind, through a conjugal union. In other words, the male and female of the same species, being the same kind, can reproduce themselves, according to the Word of God; according to the mind of the Spirit of God, and as such, **You cannot use the liberty of marriage in the Lord to tear down the truth of reproduction, for that also has its divine place!** Exactly!

Here also came Raymond Jackson, the chief apostle to this last age, in his message titled, *Satan's Last Strike*, Part 1, page 15 of the Contender of 1999, and this is what he said concerning interracial marriages: ***"Satan knew that by crossing those Cainite women with the sons of God, the very law of reproduction that God set in motion in the beginning, when He said, Be fruitful and multiply and replenish the earth,***

would eventually bring forth what he (the devil) was looking for. God wanted future generations to understand one thing, when you start messing with my laws and genetic attributes, I will give you something that shows my displeasure in it. That is exactly what He did. Giants were born as a result of that cross breeding." Let us hold that quote for a little while. Brother Jackson is making a serious statement right here, that when people mix marry, God will show His displeasure in that produce. And that is why, brothers and sisters, sometimes the product of such marriages brings forth something that shows the genetic imbalance in that produce. You see a genetic imbalance. Sometimes the products of the mixed marriages look very strange; they are sometimes very strange looking. It is a genetic imbalance that is being expressed in the offspring. Brothers and sisters, it is God showing His displeasure! Are you listening to me? It is God showing His displeasure. Look at what happened for instance in South Africa, and I say this with love and

respect for my precious brothers and sisters, for we appreciate them very much. This is not about them, but it is about a fact of the South African people. When the Dutch people took over South Africa, they decided to mix it all up, and hence, when you look at the South Africans, their ancestry is from Europe, from Asia, from Khoisan, (which in its sub-breakdown gives us the Khoikhoi and the Xhosa people), and their ancestry is also from the Zulu people. Are you listening to me? Their ancestry, their genetic root, takes in the Europeans, it also takes in the Asians, as well as Khoisans, and the Zulus, who are the local people. But brothers and sisters, when you look at it, the Dutch had one policy: They were not going to use the local people as slaves to work on their farms. They decided to bring in slaves from Asia, and as such, they went to the people of Malay. The Malay people gives you the people from Indonesia and Malaysia. So they went to Indonesia and Malaysia, and imported slaves that they would use on their farmlands. Brothers and sisters, the first batch of Malay people arrived in

1657. The Dutch, who are the settlers from Holland, began to mingle their seeds with the Malay people, engaging in active human crossbreeding, and that produced an element of people that were both Europeans and Asians, for they also had Malayan genetic traits, giving us the "Coloureds" of South Africa. But then the Dutch also mixed with the Khoisans, the local people, creating more genetic mixture. Yet, some coloureds also began to marry Khoisans, and the intermingling of seeds continued in South Africa through intermarriage. And as if that was not enough, when the Asians from India were later introduced into South Africa, the mixed marriages with them also started, adding to the racial mixture. Church, that is why the coloureds in South Africa have their ancestry from Europe, from Asia, as well as from Khoisans. And you have to be honest and agree with me, brothers and sisters, that the coloureds of South Africa are a strange looking people. I say that with respect, but the fact is that they are suffering from the result of a genetic imbalance. The first time my wife and I went to South

Africa, and we saw this element of people, we realized instantly that something was wrong, because of the way they look. I do not say that to be rude, or to bring down the people, please! We should be able to look at facts, without taking offence, because we are all God's children; we are the redeemed of the Lord; we are on the Amen side, and as such, all what we are saying does not take away from who we are in Christ Jesus. But brethren, when I first saw them, I looked at my wife, and I said that a lot of these people look very strange genetically. They have strange looking genetic features, physical features, and this made me search for the cause much later. As Wikipedia even states concerning the coloureds: "**Genetic studies suggest the group has the highest levels of mixed ancestry in the world.**" Think about that! But let us ask ourselves: Why did the Dutch do this? Why did they adopt this policy? They did not embark on this interracial mixture just because of their farmland. And please do not expect modern day books where history is being re-written, to tell you the truth. The fact

is that they wanted to take over South Africa, and they feared the Africans. They felt that if they could water down the black population, they would have a better hold over the people, particularly as they were afraid of the Zulus. Just look at it even as it stands today. Brothers and sisters, the total population of South Africa according to the 2011 Census Data Statistics of South Africa, was about 52 million. The whites of South Africa were four million, five hundred and eighty six thousand, eight hundred and thirty eight people, which is just a little under 4.6 million, which comes to just about 8.9% of the total population. The coloureds stood at four million, six hundred and fifteen, four hundred and one people, which is just a little over 4.6 million, similarly making about 8.9% of the total population. The Africans, who are the blacks, stood at a whopping 41 million, nine hundred and thirty eight people, just a little over 41 million, making up a total 79.2% of the total population. However, the white people in South Africa, who are less than 10% of the population of South Africa, own about 87% of the land of South

Africa, as of 1994 when Nelson Mandela took over power in South Africa. And let me inform you that as we speak this very day, nothing has changed with respect to land ownership in South Africa, despite all Government talks! That is a bitter and tragic fact! Look at all the land in South Africa: There is enough land for everybody, but the white man sits on everything, because of gross selfishness and extreme greed. It is very wicked, most unacceptable, and indefensible! But this is their world; they rule it! Let them enjoy it now, for the Lord is coming soon, and everything will change! Yet, a great portion of the land is nothing but a wilderness, untouched and uncultivated, and the black people, the rightful owners of the land, people who make up about 80% of the population, for we are talking about what God called "**the tabernacle OF HAM**", have nothing! That is why I cannot wait to put this message titled, *The Prosperity of Serpent Seeds*, in the Scribe. I am trying to show you something. When the white people took over South Africa, they were afraid of the blacks. And because

the population of the blacks was too much, they wanted to water it down, in order to take over the land, as they did it for economic and security gains. So they began this agenda, a conscious design of mixed marriages. They thought that by interracial marriages, they could wipe out the African people of the land. But remember what was done to the Hebrews, (the Jews), in the land of Egypt: The Egyptians were killing their babies as soon as they were born, in order to bring down their population. However, the more they killed their babies, the more the Hebrew women produced. Brothers and sisters, the more the Dutch mixed, the more the blacks were breeding, and then they realized that that policy agenda would not work, and as such, they had to change tactics. But the damage was already done, and the product of the mixed marriages are the coloureds. And let me say this, and I want everyone to know. I have met a number of coloureds, and they are a very lovely people. They are also down trodden, for they are not allowed to rise, except to be just house servants to the white people. They are

used as domestic servants, and to cultivate the land. The white people use them to tend to their vineyards, and on payday, they are not given full salaries, but half salaries, and the other half is paid to them in kind, for they are given wine, the products of the vineyard as salary. This leads them into a drunken lifestyle, and it starves their families of necessary funds for their daily survival! Moreover, the coloureds have no culture, no food of their own, no language or tongue, even the Afrikaans that they speak belongs to the Dutch; they have nothing, except to follow the whites in their ways, for they have no racial identity, being a completely mixed race of people! What a world! But this is Satan's kingdom! His kingdom thrives on inequality, wickedness, injustice, pure hatred, racial prejudice, unrighteousness, greed, and selfishness to the extreme. But the kingdom of our God is coming to power, and we will have a kingdom that is established strictly on righteousness and goodness; for EQUITY (FAIRNESS), and righteous principles, will rule this planet from coast to coast, with love and faith as its bedrock, for as it is

written in Isaiah Chapter 11, verse 9: ***“They shall not hurt nor destroy in all my holy mountain: for the earth shall be full of the knowledge of the Lord, as the waters cover the sea.”*** The knowledge of the Lord shall cover the earth, as the waters cover the sea. Amen! This world is not our home: We are seeking a city to come.

Church, I am making a serious point, and I do not want it to be lost on you. I was saying that the first time we went to South Africa, when I saw the coloureds in their physical composition, I knew that something was wrong, because they looked very strange, physically speaking. Yet, those poor folks are not responsible for that sad state of things, for it is the work of the Dutch settlers in South Africa. However, this confirms, for that is what it shows, and it is the truth, that when you mess with God's laws of reproduction, it produces a genetic imbalance, which is God's way of saying, I am displeased! And that is precisely why in Genesis Chapter 6, when ***“the Sons of God”*** began to go in onto ***“the daughters of men”***, taking wives of them as they pleased, engaging

in interracial marriages, the result was the genetic imbalance which produced the giants recorded in that passage of Scripture! Yes! When the sons of God saw the daughters of men that they were fair, and they went in onto them, the result were giants, men of renown; not necessarily in physique, for it was also in intelligence. They were called ***“men of renown”***, people who were accomplished in their fields, whether as scientists, like Stephen Hawking, or as Computer wizards, like Steve Jobs, or as musicians, like Michael Jackson, or as basketballers, like Michael Jordan, or as golfers, like Tiger Woods. But not one of these ***“men of renown”*** in Genesis had his name written in the Bible, for they were not of God! This lets us know undoubtedly that the issue in Genesis Chapter 6, was much more than the fact that believers married unbelievers: It was also that the mixed marriages created a genetic mix, and the giants produced as a result of this mix, speaks specifically of God's displeasure to that racial mixing, for they were the fruits of that union! Consequently, we must see, that the issue of mixed

marriage goes beyond the issue of unequal yoking in 2 Corinthians Chapter 6, for it is one which also devolves upon the law of reproduction, in Genesis Chapter 1, verses 11-12, where God requires that **EVERY SEED MUST BRING FORTH AFTER HIS KIND!** This Scripture has its place, and must be given its place, for it is what covers reproduction, **ALL REPRODUCTION!** Yes, I agree that the Word of God concerning unequal yoking in 2 Corinthians Chapter 6, has its place, however, you must also know that it does not take the place of Genesis Chapter 1, verses 11-12, which requires originality in seed reproduction! And neither can you use 2 Corinthians Chapter 6, to nullify Genesis Chapter 1, verses 11-12! That is the point, for they both have their place of application, and you cannot use one to knock off the other! The Lord being my helper, I will show you something this morning. But you must understand, that you cannot mess with God's genetic law: You will reap something in return. That is precisely what Brother Jackson was saying in his quote. I am just trying to explain it to you. Coming back to the

Contender of 1999, titled, *Satan's Last Strike*, Part 1, page 15, concerning mixed marriages, Brother Jackson said: ***"Satan knew that by crossing those Cainite women with the sons of God, the very law of reproduction that God set in motion in the beginning, when He said, Be fruitful and multiply and replenish the earth, would eventually bring forth what he (the devil) was looking for. God wanted future generations to understand one thing, when you start messing with my laws and genetic attributes, I will give you something that shows my displeasure in it. That is exactly what He did. Giants were born as a result of that cross breeding. Why in the world would giants need to be in this environment? Not all were born giants, some were born intellectual wizards. Do not take offense at what I say, but be realistic and listen to the outcome, that which the devil has been after for all the centuries of time since that mixing of the two lines began. Every one of those men, where it refers to them as men of renown you must***

ask, What did they reach recognition in? They had a mental outlook and an understanding about certain things that was beneficial only to an earthly minded creature. Not one of them were of the sort that could point man toward righteousness and show him how to live for God. The reason for this was obvious: It served the devil's purpose. If he could get this gene that has developed these attributes brought together with those of the other side, he will eventually succeed in crossing these negative genes into the other line. In other words, There was a line of pure sons of God up to a point where the only thing lacking was eternal life, because death had been imputed as a result of Adam and Eve's disobedience. Death was imputed, but that did not stop the devil. He wanted those sons of God to be just exactly like the Cainite line of people. I have a reason for saying this. I am coming right down the corridors of our colleges. Some of you might not like what you will hear, but I have to say it. We have all these

intellectual geniuses in our colleges today, all of which are behind our politicians as they design this nation for a New World era and the twenty first century. They aim to cross every race of people in America until eventually there will no longer be a white man, nor a black man. We will become a multi-cultured element of people. Is that bad? Yes it is, because God did not design it like that. You are going to wonder then, who did design it this way? The evil one, the devil, the enemy of all that is righteous and holy. We have a lot of professors who might hear this and be offended, but I have to say, Stick around and see where it all leads. You are putting something together that God is displeased in. My Bible tells me what was going on at the time of the flood, and why God sent the flood. GOD CURSED THAT ELEMENT OF PEOPLE. He only saved eight people alive to repopulate the earth: Actually only six to repopulate, because the whole earth has been repopulated by those three sons and their wives. It was through the

loins of the three sons of Noah and their wives, that these characteristics and genetics have been mingled throughout the whole earth. If you study the names of those sons, you will find they are the Progenitors of every race on the face of this earth today. It seems that we have a generation of leadership with a super minded philosophy which says, LET'S MIX THEM. I SAY, WHEN YOU DO, YOU WILL HAVE A DEVIL. I have read history on this very thing. Every city and every nation that has ever tried to mix the races and create a compatible society, that original element of society perished. Go on and do it, and see what you get. When you start messing with the law of God that brings mankind into existence you are asking for trouble: God wants that to still be according to His design, not yours.

That is a very serious quote, scripturally deep, and most sound, and it dovetails perfectly with the teaching of Brother Branham on this issue of mixed marriages! We are now going to take the quotes of these two men, and build a message on it,

strictly by the Word of God, for their quotes are absolutely and unshakably Bible based, for as it is written in Genesis Chapter 1, verses 11-12: EVERY SEED MUST BRING FORTH AFTER HIS OWN KIND! And we know that God made all seeds to be of different kinds, giving variety to seeds, all seeds, bugs and bacteria, insects, plants, fishes, birds, animals, and man. And because every seed is to bring forth after his kind, is precisely why to every male, there is a female. Every male species of God's living creature has a female, which is his female counterpart, with which he is to reproduce himself. Even plants and flowers have their female parts, their reproductive parts, whatever the species. They have a male part and their female part. That is why on a plant, there is a part that stores the pollen grain, which is the carrier of the seed, the germ of life of that plant. There is also a female part that receives seed in a process of pollination, and it is called the stigma, which in turn carries the seed through the style to the ovary, which contains one or more ovules, one of which develops into seed, in the

process of fertilisation. One thing is certain, brothers and sisters, every living thing, every living organism, not only has its male part, it also has its female part, and that includes human beings! So, we ask: What is the female given for? What is she for? It is strictly for reproduction, through the act of mating, as in fishes, birds, animals, and human beings, and through the act of fertilization, in plants! This is precisely why God made it that to every male there is a female, so that the very specie of male may have his counterpart to reproduce himself by, that he does not bring forth or produce a mongrel or a hybrid. That is also why God gave ability to every seed, for in every seed, there is a germ of a new life. I repeat: In every seed, in every original seed, there is a germ of a new life. I do not care what kind of seed it is, whether of plants, or of birds, or of fishes, or of animals, or that of man, in every original seed, there is a germ, an attribute of life, a germ of a new life.

Church, in every seed, every original seed, there is a germ of a new life, to enable it to bring forth a new life exactly after his

original kind, as God declared in Genesis Chapter 1, verse 11: ***“And God said, Let the earth bring forth grass, the herb yielding seed, and the fruit tree yielding fruit after his kind, WHOSE SEED IS IN ITSELF, upon the earth: and it was so.”*** Hence verse 12 now records: ***“And the earth brought forth grass, and herb yielding seed after his kind, and the tree yielding fruit, WHOSE SEED WAS IN ITSELF, AFTER HIS KIND: and God saw that it was good.”*** Everything brought forth ***“AFTER HIS kind: and God saw that it was good.”*** Saints of the living God, this was made possible, only because the males mated only with their female species! Period! There is no other way for this Scripture to have been fulfilled on that day, if not for the fact that the male seeds took on their female counterpart seeds! God not only put a germ of new life in all original seeds, He also gave that original seed species his female counterpart FOR REPRODUCTION, in order to maintain originality of seeds, and to guarantee originality of species. Come with me to the Word. We have a number of

Scriptures we are going to explore this morning. In Genesis Chapter 1, God speaking to His angelic helpers, angels who are also made as spirit beings, and in His image, God declared, as recorded in verse 26: ***“And God said, Let us make man in OUR IMAGE, after OUR LIKENESS.”*** Yes, this gives us a spiritual image and a spiritual likeness, because God is not flesh and blood; He is not a physical God with a physical substance, but He is spiritual. Nevertheless, apart from the spiritual image and likeness of God which God's children bear, they also bear a physical image and a physical likeness, because they were also put in a body of flesh, to inhabit a physical world! Come on! Consequently, we must realise that the law of reproduction recorded in Genesis Chapter 1, verses 11-12, applies first to the physical MAN SEED. God spoke that law for physical seeds, all physical seeds. However, because the natural types the spiritual, and further, because the law of reproduction of God is one, that law also applies to spiritual seeds as well. But we must realise that the law of reproduction in

Genesis, was spoken firstly and primarily to physical seeds, and by this law, every physical living thing we see on earth today was produced. And although God made man after His own image, after His likeness, (for there is an image of God, which is not flesh and blood, but a spiritual image of righteousness, holiness, meekness, simplicity, humility, love, faith, gentleness, brotherly kindness, goodness, and virtue, which is divine power, all attributes of God's spiritual image), however, what is not debatable is that the law of reproduction was spoken to Adam and Eve, two human beings, to reproduce children on earth, human children, who will fill the earth! So, yes, God made man after His spiritual image, but He made him to be flesh and blood, and with bones, from the dust of the earth! And now as flesh and blood, bearing a physical image, and with a specific physical likeness, God now gave them a commission on that basis in Genesis Chapter 1, verse 28, as it is written: ***“And God blessed them, and God said unto them, Be fruitful, and MULTIPLY, and replenish***

the earth...” Brothers and sisters, in Genesis Chapter 5, verse 1, the Bible reads: ***“This is the book of the generations of Adam. In the day that God created man, in the likeness of God made he him.”*** (Listen to verse 2): ***“Male and female created He them...”*** Why? It is for the sake of reproduction, that a man may have his female counterpart, one in his own very image, and after his likeness, that by her, he may reproduce himself, his own very kind. The offspring becomes a produce after the image and likeness of the father and mother. That is the mystery and the beauty of a conjugal union: That a man and his wife will bring forth after their image, and in that offspring, in that little baby boy or girl, you can see the mama in the shape of the lips, in the nose, and in the eyes of that baby; but when you look at the complexion, it is just that of papa, and vice-versa. (Brother Amos points to the chart). He has some of daddy's genes, and also some of the genes of mummy. And when that baby is set forth before people, they are not going to say: ***“Where did this one come from? Is this your neighbour's child?”*** Are you

listening to me? They will not say that because they can see you in that offspring! When God gave Adam another seed, after Cain killed Abel, Genesis Chapter 4, verse 26 records: ***“And Adam knew his wife again; and she bare a son, and called his name Seth: For God, said she, hath appointed me another seed instead of Abel, whom Cain slew.”*** Halleluia! Now let us go back to Chapter 5, and see what it says in verse 3: ***“And Adam lived an hundred and thirty years, and begat a son in his own likeness, after his image; and called his name Seth.”*** In other words, he gave birth to a son who looked like him, genetically speaking! This is so, because everything is ordained to bring forth after his kind, and you are not going to change that. And as bride saints, it is very imperative that you understand God's objective for creation; why He created Adam and Eve. I want to say this morning, that the objective of why God put Adam and Eve here, in spite of the fall, and regardless of the fall, still remains inviolate. I want to remind you this morning, that the objective of God for creation remains the same,

even as we speak. Brothers and sisters, you have to agree with me this morning, that although the fall came, God working through the fall, still had every son and daughter He ordained to have in this world, before the world was formed. Meditate on that! Through the law or **“the tree of the knowledge of good and evil”**, which is sex strictly for pleasure, every son and daughter of God is being born on this planet today. So the desire of God still continued despite the fall, except that He now has to redeem them, for He made a way to have them redeemed. So redemption is ordained for God's fallen children. Consequently, if the fall had not happened, God would still have had the same children He now has, but without the need for redemption, for they would not have had death in their blood stream, and neither would they have had any fallen nature. And despite the fall, God still has every son and daughter that He pre-ordained to have, but now, He has to redeem each and every one of them, which is why redemption was set in motion. Redemption is to bring seeds back to a state that should have been, a

state that they would have had in the beginning, had there not been a fall. So I want you to understand this morning, that had the fall not taken place, the reproduction of seeds after His image and likeness would have remained, for it would have been maintained and sustained. And even now in spite of the fall, God is still having His natural children, but He is taking them through the process of redemption, the process by which He will receive them back to Himself. I am simply letting you know that THE COMMISSION for reproduction which God gave to Adam and Eve way back there in Genesis, AND THE LAW of reproduction which God established to guide that reproduction Commission, is still on course, for it is infallible and immutable. And there is no Scripture you can use to nullify man's reproduction commission, and neither is there any Scripture you can use to nullify the law guiding this reproduction! Full stop! Chew on that! In effect, I am simply saying this: On issues of marriage, we are ruled by two laws, two fundamental laws: The law forbidding unequal yoking, AND the law which guides reproduction! Catch

that! One law guides our choice of a spouse on the basis of faith, to secure our spirituality, and the other guides our choice of spouse on a racial basis, to secure the originality of our racial species or racial product, producing natural sons and daughters for God in our physical racial image, after our physical racial likeness, which is strictly genetic! This is the truth that the religious world is not seeing, but that is exactly what you must see, as eagles of God, for it gives you the total picture, the complete picture, and it is the wholesome picture God wants you to see today! Come on! You must see it, for it is written: **“... THE WISE SHALL UNDERSTAND”!** The commission for repopulation which God gave Adam and Eve at the beginning of the first world, and which, at the beginning of our world, this second world, was also given to Noah, Shem, Ham, and Japheth, has not been fully realized, and is still on right now. We even have to realise that it is now, in this last age, and in this last move, that the Millennial subjects, people whom God will use to repopulate the earth in the Millennium, are being born all over the

world, for the commission of the reproduction of seeds is still on, for it is operational, and as such, the law of reproduction holds, even as we speak, being God's infallible and unchanging law. Come on! How are you going to get away from Genesis Chapter 1, verses 11-12? You cannot, for it is God's infallible and unchangeable law of reproduction! Moreover, marriage is given mainly for reproduction, apart from the companionship it also gives!

Brothers and sisters, Brother Jackson made a very serious statement, for it is true that Satan had an objective in that day for introducing mixed marriages, as recorded in Genesis Chapter 6, which is precisely why you must never take your eyes away from the law of Genesis Chapter 1, verses 11-12, on issues of marriage. Now look at it, for we want to take a close look at this thing. In the beginning, God wanted children for Himself; He wanted a human family. He had already received to Himself an angelic family, after all the angels had first been tested. In that test, some angels fell, whilst some

were faithful. The fallen angels had no opportunity of redemption, but are reserved for the lake of fire. They did not have a second chance. They fell once, and that was it, for their eternal fate was sealed irreversibly. But now, God made man, because He also wants a human family, and He would use the first pair He created to reproduce many more just like themselves. But the devil, knowing that he cannot create, for only God is the creator, and seeing he had the evil ambition to make himself god, he realized that he needed a natural seed, if that was to be possible. Lucifer, the fallen cherub, realized that he needed a seed. And since he could not create one, he decided to use the Serpent creature to accomplish his evil ambition, for he knew that he could not get Adam and Eve to worship him. So his first step was to get a seed, and he went straight for the Serpent, knowing that in all the animal kingdom, the Serpent was the only creature whose seed could mix with that of man, and he used him. Contrary to the carnal teachings and hand-me-down traditional projections we had been taught in the religious

world, the Serpent was not a snake, for it was the curse of God that transformed him into a snake at the Judgment bar, according to the record of God in Genesis Chapter 3. Before that judgment, he was an upright creature, one who looked more like man than an animal, for he was at the head of the animal kingdom, being the highest form of animal life that God has ever created. He is the missing link between man and apes which the scientists are looking for. It is not the Aborigines of Australia that are the missing link between man and the primates. I say that only because there are people that are teaching that it is the aborigines of Australia that are the missing link. Brothers and sisters, that is the extent of their prejudice against the aborigines! I do not believe in their way of life myself, for they worship the forest and all that nonsense, just as the Native American Indians do; but for goodness sake, they are part of the homo-sapiens; they are part of the human family; they are part of the brotherhood of man, however differently they may look, for God is a God of variety! Even in plants, birds, fishes, and animals,

some of them are odd looking; but they are still part and parcel of the creation that they belong to! Not all birds look beautiful! And not all animals look beautiful, just as not all men look beautiful, if all you want to consider is fleshly beauty! The truth is that God makes some very beautiful, whilst some are not so beautiful. The Lord also makes some that are plain and bland, whilst yet, others may even look ugly, God expressing His power of creativity, beauty, and incredible diversity. I have seen some land animals, and some aquatic animals, that I have had to wonder, what on earth is that? simply because they look scary! You just have to appreciate the creative power of God, the beauty of His creation, and its mind boggling diversity. Brothers and sisters, the aborigines are not the missing link as some white preachers are making some to believe. Oh, my! The aborigines are still alive today as a distinct race of people, and they were not transformed into snakes as the judgment transformed the missing link in Genesis Chapter 3, verse 14! So how can they make the aborigines of Australia the missing link?

That is a carnal projection that is being made by some Japhetic people. And that is why they also treated them the way they did, very badly, taking over their land. God allowed it though, because all that the aborigines know is to worship the forest and demons of all sorts, just like the Canaanites, whom God used the children of Israel to wipe out, taking over their land, all because of their gross idolatry. It is the same reason why God moved out the Native American Indians, for their worship of all sorts of demons, and gave their land to the white race, because God has a plan for that continent. It is a shame though that the United States of America has lost her Christian image. She is no longer a Christian nation, and it is blasphemy now to say that America is a Christian nation, for she is not! They have no clue to anything of life, and it is a sick and degenerate society of people! They are a sorry case! Brothers and sisters, they have turned their back on God! They are the ones that are bombarding the world with these hoards from hell called LGBT. Brothers and sisters, I am making a point. Satan could not

create anything, and so he inspired the Serpent creature to have an intimate relationship with Eve, just for pleasure, and out came Cain, Satan's vicarious child (Satan's indirect child). It is so because Satan was behind his birth, for he motivated everything. However, that intimate relationship strictly for pleasure was also introduced to Adam, and that also produced Abel, creating two seeds in the womb of Eve before the birth of Cain, by a medical conception called superfétation. Subsequently, with the enmity which God spoke between the two seeds being at work, Cain slew Abel, and God had to appoint Adam another seed called Seth, which as it is written in the Gospel of Saint Luke Chapter 3, verse 38: "... **Seth, which was the son of Adam, which was the Son of God.**" That makes Seth also a Son of God. But Cain is the son of the Serpent, and that makes him a son of Satan. And that is why Apostle John, in 1 John chapter 3, speaking of Cain in verse 12, declared: "... **Cain, WHO WAS OF THAT WICKED ONE, and slew his brother...**" Brothers and sisters, I am simply

saying that the devil succeeded in getting a seed for himself, called Cain, and having accomplished that, he could then set his next move in motion. However, this gives us two lines or two streams of humanity who are very different and distinct, and who are also directly opposed to one another; two direct and opposite streams of humanity. It gives us the Sethite lineage, and the Cainite lineage; the lineage of the **"Sons of God"**, and the lineage of the sons of **"Men"**, who had daughters born unto them, according to the record of Genesis Chapter 6. The devil now realized that having gotten seed unto himself, he could now use that seed to brew up a population of females that he could use to strike at the Sons of God, in order to break down their pure genetic state, so that they would have his attributes and indirectly live for him. It was therefore females galore in the earth! In the same vein, and for the same reason, at this end time, we now still have an explosion of females around the globe, for the ratio of women to men is about seven to one, based on the prophetic revelation of Prophet Isaiah in

Chapter 4, verse 1, for it is simply prenominal, and it is all for societal degeneration! Remember that as it is written in the Book of Isaiah Chapter 14, verses 12-15, Satan wants to be like God, and worshipped. And as long as the two streams of humanity continued as it was, his ambition would not be achieved. So he decided to take the next step, which was his second step, of crossbreeding or interbreeding of seeds, (mixed marriages). This brings us to Genesis Chapter 6, verses 1-4, which declares: **"And it came to pass, when MEN"** (who are not the sons of God; but carnal men, the Cainite men), **"began to multiply on the face of the earth, and daughters were born unto them, That the SONS OF GOD"**, (who are the Sethite men), **"saw the daughters OF MEN"**, (the Cainite daughters), **"that they were fair; and they took them wives of all which they chose. And the Lord said, My Spirit shall not always strive with man, for that he also is flesh: yet his days shall be an hundred and twenty years. There were giants in the earth in those days; and also**

after that, when the sons of God came in unto the daughters of men, and they bare children to them, the same became mighty men which were of old, men of renown."

No, it was not something that happened overnight. It was how the daughters of the Cainites, daughters of mortal or carnal **"MEN"**, were inspired by Satan to dress seductively, and conduct themselves provocatively, in order to tear down the moral resistance of the lineage of Seth, the Sons of God. They were a shameless bunch of humanity, like what we have out there today. The bunch of women we have out there today are not ladies. Ladies are now very rare, very scarce, for true ladies know how to dress, and how to conduct themselves with decency and dignity, and with shamefacedness. You find them in the bride. But out there, there are no ladies: They are prostitutes, shameless human beings, people that cannot blush! They say openly, and even on the television: **"If you've got it, flaunt it."** So they bring out their breasts like wares for sale, and bring out all their backsides in their hot pants. Aged mothers do it,

grandmothers for that matter; mothers do it, and the daughters do it very well. All of them are trading in breasts today, and wearing hot pants, these shameless bunch of humanity! Look at Hollywood. Sometimes they come on the Catwalk, and they wear nothing but just a see through veil, baring all their sacred parts for the whole world to lust after. How they love it and glory in their shame! You see their whole buttocks and entire breasts; you see all their shame, as they display and smile to the camera on the red carpet. What makes people do that? What makes people lose all sense of self-dignity, self-esteem and honour? It is precisely because they are from this lineage of **“Men”** who had daughters, the Cainites. (Brother Amos points to the top left corner of the chart). And that is why as a child of God, you will dress right; you will cover yourself, or something is seriously wrong with you! If you constantly refuse to dress right, I will tell you your problem this morning: It is that you have a dirty spirit upon you! The spirit that is ruling you is a filthy one! You have given yourself over to Lucifer to

use you as an agent of lust, a bait unto immorality! You should know that it is not water that is flowing through the veins of brothers, but red hot blood. So that means that you can be tempting and alluring by your dressing. And as such, you owe your brother a duty of care. You are your brother's keeper, and as such, you owe your brother a responsibility to dress right, except you have the spirit of seduction ruling your life. And let me warn you brothers, because you do not need to be naive: Sometimes, sisters so-called present themselves indecently on purpose, for they do it knowingly! They do it, and they do it intentionally! They know exactly what they are doing! It is you who is wondering why Sister X is dressed like this that is naive. Sisters know exactly why they choose to dress alluringly, when and if they do, because this is still a mixed multitude! And unless you allow the grace of God to guide and rule your life, that so-called sister may be a bait of the devil to get you and ruin your life! We are not Serpent seeds, but sons and daughters of God. Therefore we dress in righteousness, and we

walk in righteousness. Our appearance speaks of who we are: God's holy righteous children, children of light, a light in a dark world. However, brothers also owe our sisters the duty of care to dress right, not following the fashions of the world, and wearing these stupid tight-fitting trousers that men are now wearing out there, like stretch jeans, which reveals all of your bulge, if you know what I mean by that, for God expects you also to be sensible! I have to run along.

We are making a point. When we come to Genesis Chapter 6, what made the sons of God take as many wives as they chose? It was the constant bombardment of their resistance by the seductive dressing of the Cainite daughters, and their provocative attitude. And before you knew it, they began to fall, as lust took over the lineage of the Sethites. And if there was no lust, why were they choosing many wives as they chose? There is only one reason why a man cannot have enough wives; only one reason that makes a man go on marrying wives, as many as he can get. He certainly has an insatiable appetite for

women. Period! Brothers and sisters, Jacob Zuma, the current President of South Africa will be marrying his seventh or eighth wife very soon. What makes a man, a president, do that? There is only one problem: He has the spirit of lust upon his life! Period! Consequently, he cannot resist anything in a skirt: *"Oh, I must have this one too... Oh, that lovely one; I must have her as well."* Brothers and sisters, the point is that the sons of God had their will to resist broken down, and mixed marriages started, until we come to Genesis Chapter 6, the mixed marriages had come to its head or climax, and God decided, *"I will cut everything short, bringing it to a close, and start afresh."* Brothers and sisters, what was the devil's objective in all this? It was that by crossbreeding, by mixed marriages, the evil genes of the Cainite daughters would be mixed with the righteous genes of the Sethite lineage, thereby producing mixed seeds, where the evil genes will have the upper hand, because the evil gene is dominant. Simply take a clear glass, and fill it up to the brim with water. You can see through this glass that it is crystal clear.

(Brother Amos lifted up a glass). Fill it up, then drop just one drop of iodine into the water, and it will become black. Just a drop of iodine will do, and it will become dark. But now, fill another clear glass with dirty murky water, and now take a drop of clean water, and add it to the murky water, and you will see that it makes no difference. You know why? It is simply because the evil gene is dominant! So Satan's scheme was simply to take the evil genetic nature of the Cainite daughters, and through mixed marriages, breed those evil genes into the seeds born from that union, and the seeds become defiled, genetically. Because the offspring will certainly take more of the evil genes than that of the good! And by having more evil genes, such offspring will not listen to God; they will listen to Satan, doing the bidding of the flesh. And the more evil genes are bred with that lineage, the worse they get in what is produced! Absolutely! Brothers and sisters, the more the evil gene is being bred and rebred, the worse the condition gets. Satan succeeded in brewing down the pure genetic state of the sons of God. I will

remind you that in the beginning when Adam sinned, God told him in Genesis Chapter 2, verses 16-17: ***"And the Lord God commanded the man, saying, Of every tree of the garden thou mayest freely eat: But of the tree of the knowledge of good and evil, thou shalt not eat of it: for in the day that thou eatest thereof THOU SHALT SURELY DIE."*** Period! All Adam had to bear for his disobedience was death, no more and no less! But remember that it was not a day of twenty four hours, but a figurative day of a thousand years; and before the thousand years came to a close, Adam was in the belly of the earth, dead, just as God had said he would be. And nobody lived a full one day of a thousand years. The oldest man ever to live on this planet was Methuselah, who lived 969 years, and yet, he still fell short of one day, just as God decreed. So when Adam fell by disobedience, all that was in his bloodstream was the imputation of death. He had no evil gene within him; there was no evil gene within his DNA. The only negative thing he had was the imputation of death in his bloodstream. He would have lived for so long, but

before that figurative day came to a close, he would have died, and he died. But he was a pure son of God, genetically speaking, just as Eve was a pure daughter of God. Remember that Adam was a Son of God, an original pair with Eve, genetically, having no evil gene whatsoever, and the devil knew that. He needed to breed down the genetic state of the Adamic lineage, which was carried on by Seth, through mixed marriages. And if Adam was pure in his genetic constitution, having no evil genes in him except the imputation of death, and we know that he was, scripturally speaking, common sense will tell you, therefore, that Seth, his offspring, was also pure, being also an original seed; because every seed brings forth after his kind. Since Adam was pure, and Seth was appointed by God in the place of Abel, then Seth was pure, having only the imputation of death in his bloodstream as well. Correlatively, since Seth was pure, then Enos, his son, was also pure in his genetic constitution or DNA, for like begets like, being strictly a matter of seeds: Every seed brings forth after his kind!

However, the name of Enos is prophetic, and it means "mortal man", speaking prophetically of the fall of the Sethite lineage in their genetic constitution through mixed marriages. And in the day of Enos, mixed marriages started. We have a message on that in the Scribe titled, *Genesis: The Mixing of Seeds*. The point is that his name was prophetic of the attack of Satan, even though he was a pure Sethite himself. Consequently, by the revelation of the Word of God, we know assuredly that mixed marriages started in the days of Enos, and by the time Noah's days came, the mixing of seeds had come to its head, and God was now going to judge it, as recorded in Genesis Chapter 6. And I will say it this way: In Noah's days, there was no longer any pure Sethite. Even Noah himself was not a pure Sethite, because the mixed marriages had come to its head, which was why God decided to bring it to an end. That was not the beginning of it; that was the end of it; and it lets us know that although Noah was a son of God, being a Sethite, he was not genetically pure himself. The proof of that is

that Noah found grace, unmerited favour, with God. Period! And let me tell you more: When God wiped out that world, which was given to rollicking, wining and dining, right after God wiped them out, Noah planted a vineyard, and he made wine, and drank himself to a drunken stupor! He continued the lifestyle for which God had judged that era! We are not querying his having a vineyard, or even for taking some wine. It is his lifestyle of drunkenness that is most unbecoming of seeds, particularly a prophet of God, which lets us know that truly, it was only the grace of God that made the difference in Noah's life, for he was also genetically defiled, for he was certainly not a pure Sethite. Period! The prophet of God drank wine until he removed all his clothes, literally, and lay flat in his tent, totally naked, and passed out from his drunken stupor! Ham came and saw his father lying stark naked, and made fun of him, and God judged a particular seed in his loins for this act of disrespect, a seed named Canaan, one who later became his fourth seed. That should let everyone see that Noah was not as genetically pure as Adam was, or as Seth

and Enos were, as they were men who only had death imputed into their bloodstreams, but with no evil genetic traits in their DNA. Come on! And to those who want to argue with that, I will simply ask you: Where did Noah get that evil attribute of drunkenness from, seeing that the heart of man is the control tower? Come on! Enos was not a drunk! Seth was not a drunk! Adam was not a drunk! So where did he get his trait for drunkenness from? Are you listening to me this morning? Because it is one of the traits for which God wiped away the world in that day, as recorded in Luke Chapter 17, verses 26- 27: ***“And as it was in the days of Noe, so shall it be also in the days of the Son of man. They did EAT, they DRANK, they married wives, they were given in marriage, until the day that Noe entered into the ark, and the flood came, and destroyed them all.”*** The question is: Are we not to eat and drink? So, what does the Lord mean? Why did God judge them for it? Firstly: It was that they were given to it without caring for their walk with God, for it was at the expense of the salvation of their souls, being

preoccupied with it. Secondly: It was the evils or the vices that accompany drinking, (particularly when care is not taken), that took over humanity in that day, and as a result, you had a lot of people, just like today, who were nothing but drunks, and Noah fell right into the latter category! Yes, he did! Come on! And just as Brother Jackson was used of God to teach us, we know by the revelation of the Word, that the mixed marriages came to its head or climax in the days of Noah, for in his day, God brought it to an end, wiping the slate clean, and He started afresh. This is further proof that everything had come to its completion in Noah's hour, for as it is written in Genesis Chapter 15, verse 16, when ***“the iniquity of the Amorites is not yet full”***, God does not judge a thing! So Noah, although he was a righteous seed, being a son of God, nevertheless, he also had evil genes in him, on account of the mixed marriages that was going on on a large scale, and which started ever before his hour of time! I am speaking of his genetic constitution, because in him were both righteous and evil genes. Hence, although God wiped away

the race of Cain in the flood, nevertheless, through mixed marriages, the Serpentine gene had been introduced into the DNA of the Sethite lineage, and the seeds were no longer pure. However, one thing stands out, and that is that he had a genetic constitution that was much better than his peers, and which made him stand out above all his peers. For inspite of his fallen genetic nature, there was still something in him that God could use, and God did use. Brothers and sisters, you know the rest of the story: Noah heeded the call of God, and did His bidding, building an ark, and God wiped away the earth with the flood, and started a new world, which is this second world, with Noah and his three sons, Shem, Ham, and Japheth. But I now want to show you something, and please pay close attention.

Saints of God, right from the time of Adam to the hour that Noah was born, there was only one class of God's children on this planet; only one race of humanity on this planet, that made up the family of God's children, a people who were separate and distinct from the Serpent's seed, the Cainites. And by

that I simply mean this: The physical genetic properties of the Adamic lineage produced only one racial colour, skin colour, even though it would certainly have come with slight variations, even as we have today within the same race of people. But regardless of the variations in colour, it still gave us one racial colour bloc, which is the yellow race. I say that on the full authority of the Scriptures, because the lineage of Seth was carried on through Shem, right up to Jesus Christ. Brethren, you have to agree with me, that there had to be a difference in the physique of the Sethites, which stood them out, and made them different from the Cainites, enough for the Cainite daughters to know precisely where to direct their arrows of lust. The scriptural confirmation of this fact is revealed in the fact that before Noah gave birth, God had not yet ignited mutation, for although mutation was in Adam's gene or DNA, however, it was not activated in Adam, and neither was it activated in any of his seeds after him, until Noah gave birth, for mutation started in Noah. In other words, mutation had not yet started in man, until

Noah gave birth, for mutation started precisely in Noah. As a result, God's children shared or carried the same physical characteristics, the same likeness, and image, genetically speaking, up until when Noah was born. Are you with me? Mutation occurs when a dominant gene in the DNA, called a "**Mutagen**", which is a powerful agent of physical change, brings about a change in the structure of the DNA gene, resulting in a variant form, or a new form of species, which can be transmitted to his offspring, for it is hereditary. In short, it is a law God placed within Adam's DNA, a dominant gene that has the power to produce variety within the family of God's children, but which lay dormant in Adam, for it was not activated in Adam. We are looking strictly at their complexion, and their physical composition or makeup: The shape of their nose, the colour of their eyes, the kind of hair they had, and the colour of their skin (their complexion) etc., physical things that make us different from one another, and identifies our racial bloc. That is what mutation brought about in men! And that is what it also does in plants, animals,

and in all God's natural living creation, for by it variety was established on earth! And because mutation only started in Noah, consequently, before Noah gave birth, and until he gave birth, God had only one racial bloc of children on the planet, taking into consideration that the Serpent seeds were Satan's children, not God's children. This now brings us to the Book of Acts Chapter 17, and please follow me closely with the eye of faith, which is the eye of revelation. I am trying to show you something. In Acts Chapter 17, beginning from verse 26, Apostle Paul declared of God: "**And hath made of ONE BLOOD all nations of men for to dwell on all the face of the earth, and hath determined the times before appointed, and the bounds of their habitation.**" Let us hold it there for a little while. We are told right here that through the blood of ONE MAN, all nations of men were made. That simply means that through the blood of ONE MAN, all races of men, all colours, original colours of men that we now have on this planet, were created, by God using ONE MAN as their

progenitor. The question is: Whose blood was that? It was certainly not the blood of Adam, but was strictly the blood of Noah. It is the blood of Noah. And when Noah's children were born, he produced only three sons, which is God's number of perfection, for he did not have any daughters; the only man in Adam's lineage without a daughter, for all heirs before him had. Do not forget as it is written, that God appoints seed. So God cut off female seeds from being reproduced by Noah, for it was the end of that world, for everything had now come to its end, and God was going to start afresh, wiping out the old world, and repopulating a new world, using just the three sons of Noah, with their three wives. Noah produced Shem, Ham, and Japheth, and when his first son, Japheth, was born, (for Japheth was actually Noah's first born, even though Shem was his heir), Japheth was white in complexion, much unlike his father, and he is the progenitor of the White or Caucasian race. Are you with me? That must have totally wowed Noah and his wife, seeing the new complexion! Then Noah gave birth to Ham, his

second son, and when Ham came out, behold, he was black, and he is the progenitor of the Black race. That must have also left Noah and his wife speechless, seeing yet another new complexion! Finally, Noah gave birth to Shem, who was actually the third in the order of births, although he was his heir, and was therefore counted first, according to the order of inheritance. And when Shem came out of his mother's womb, he looked just like his daddy in skin colour and physical characteristics, for he was the one that carried the physical characteristics of Noah, which gives us the Yellow race, who are olive skinned in colour. Noah and his wife, no doubt must have said: That is more like it, being puzzled by the complexion of their first two sons, who were most unlike Noah and his progenitors in skin colour. Brothers and sisters, all three boys came out of the loins of the same father, and out from the womb of the same mother, and yet, all three of them had different genetic traits: White, Black, and Yellow skin colours, all by the law of mutation. This was the beginning of Mutation in man, the very beginning, for as I stated earlier, many

more acts of mutation were to come, and it came, producing the incredible variety of races and the original colours we have today in the earth. I speak strictly concerning men. For out of these three sons of Noah, who produced the three main races of people in the earth, came all other races we have today. So in Noah, God set something in motion, something that operates in plants, bugs and microbes (bacteria), insects, fishes, birds, and in animals. That is what is called a mutation. It is to produce a difference in species of the same creature, for mutation does not and will not nullify the law of reproduction that every seed brings forth after his kind. Mutation only enables for there to be variety of the species of that particular creature. Consequently, mutation can only produce various species of a particular creature, but it will not, for an instance, make any chimpanzee mutate into man! If the original progenitor is a human being, by mutation, he cannot produce an animal, for that is not what he is, and neither is the seed of the new life which is buried within him that of an animal, but the seed of a new

human life, just as Genesis Chapter 1, verses 11-12 records: ***“And God said, Let the earth bring forth grass, the herb yielding seed, and the fruit tree yielding fruit after his kind, WHOSE SEED IS IN ITSELF, upon the earth: and it was so. And the earth brought forth grass, and herb yielding seed after his kind, and the tree yielding fruit, WHOSE SEED WAS IN ITSELF, after his kind: and God saw that it was good.”*** It is basically that the germ of a new life, or the seed of a new life within man, cannot produce the life of another thing that it is not! This truth just throws out evolution, which states that all living things evolved from one single cell, and further that man evolved from apes. That is hogwash! It is a blatant lie, one that is most ridiculous and downright stupid! At any rate, regardless of what is being taught out there, the fact remains that God is the Creator, and His Word is Sovereign, and it will have the last say, for it cannot fail, and the bride will have the last laugh. Amen! Saints, the fact remains that by the law of mutation which God set in motion in Noah, God began to get to Himself a variety of

humanity that He had predetermined to have before the foundation of the world. Consequently, with the birth of Shem, Ham, and Japheth, we see the beginning of variety being introduced into the human race, three main races, God using Noah, and through these three races, the Lord would continue to bring about more variety in the human racial evolution, God working through the law of mutation. So the variety He has in plants, in fishes, in birds, and in animals, the Lord also wants to accomplish in man, which will now be God's human ***“flower garden.”*** Are you listening to me? We are showing you how God set His human flower garden in motion: It is strictly by the law of mutation, which was ignited in Noah. Hence the reason we all have one father, regardless of race, colour, nationality, and tribe, for the blood of one man, Noah, flows through all of us, for God used him to be the progenitor of the entire human race, as diverse and as distinct as we are, in our racial constitution. God wanted this variety in humanity, for He is a God of variety, and He finally produced this human variety, establishing

a number of different and distinct races of people on the planet, with the passage of time. As such, we cannot use mixed marriages, or even the plan of redemption, to take out the different races of people which God has gotten for Himself, through the process of natural reproduction. That is the point that you must see, as elect bride seeds of God! Hence why I stated earlier that we cannot use the truth of redemption to take out the truth of the reproduction of seeds. Consequently, the truth of unequal yoking cannot be used to nullify the truth of the reproduction of original seeds, for both are truths of God, and they both have their place. Period!

Brothers and sisters, before the Lord created the world, and before He placed man on this planet, He had decided within Himself that He would get a human family, and that they would be of different and distinct races, colours, and nationalities, for as it is written in the Book of Acts Chapter 15, verse 18: ***“Known unto God are all his works from the beginning of the world.”*** And that is why in Acts Chapter 17, the Bible

says in verse 26 about God: ***“And hath made of one blood all nations of men for to dwell on all the face of the earth, and HATH DETERMINED”*** (IN HIS OMNISCIENT MIND), ***“the times before appointed”***, (before the foundation of the world), ***“and the bounds of their habitation.”*** This absolutely means that in God's mind, He had foreordained that He would have different nations of men to dwell on all the face of the earth, in their racial variety, which is why He gave Adam and Eve the Commission to be fruitful, and to multiply, and to replenish the earth. Adam and Eve produced only one racial stock, which is the Yellow race. Noah supplied the other two main racial stocks, which gives us the White and Black racial stocks. And when the world was wiped out in Noah's day, the Lord again gave the very same Commission of procreation to Shem, Ham, and Japheth, three men through whom the law of mutation was carried on, for it was in motion, in order to produce the various nations of men we now have today, in their various racial blocs. But Acts Chapter 17 also states that God ***“hath determined***

THE TIMES BEFORE APPOINTED...” What is the meaning of that: The times before appointed? It simply means that God, before the beginning of the world, had predetermined the times of their natural and National evolution. That statement is tied to ***“the nations of men”*** in that verse, for it is in relation to ***“the nations of men”***, and it was spoken concerning ***“the nations of men”!*** God, before the foundations of the world, hath predetermined the time when each nation would evolve. And not only that, it is also written that God had also predetermined ***“THE BOUNDS OF THEIR HABITATION.”*** In other words, the Lord had predetermined where each nation or nationality would be established as their own homeland, for all these details were all predetermined in the mind of the Omniscient God, (the ALL knowing God), when He took counsel with Himself, before the world was created. We all know that God gave to the nations their inheritance, after the breakup of the building of the city and the tower of Babel. He scattered them over the earth by multiplying their

tongues, and they could no longer understand one another, and as such, each went his way. God took each family as a unit, father, mother, and whatever children they had, and gave them one language, a particular one, and when they woke up that morning, they were all speaking that same language. God was going to use that family nucleus to start something, for eventually, a nation would come out of them. Are you with me? The other families also all woke up that same morning, speaking a different language, because language is supernatural. This reminds me of the case of an English woman from Plymouth, named Sarah, who was born and bred in England, and who lived in England all her life. She had some kind of attack of migraine (headache), and when she woke up the following morning, she had lost her English accent completely, and she started speaking English exactly like the Chinese, for her accent was absolutely and perfectly Chinese! It was simply amazing hearing her speak! My wife and I watched a Television programme on it, and you can watch it on YouTube, if

you search for it with the right title. It is most incredible! Neurological tests and scans on her brain showed that she had suffered no brain injury or damage. It is like something was switched in her brain! Another English woman had a similar experience, and woke up one morning, and started speaking English like the French, for her accent was perfectly like that of a French speaking person trying to speak English! It is just incredible, but true! It is called the **“Foreign Accents Syndrome”**, and it is unbelievable that over 150 cases of people suffering from this experience abound worldwide! To me, this is God vindicating His Word, showing precisely what is to come on a global scale, and to every mortal on this planet, for God will restore to the earth a pure language in the Millennium, just as it is written in the Scriptures. Language came by God overnight, at the breaking up of the building of the tower of babel. In one day, God divided tongues to men, and likewise, in one day, in the Millennium, God will restore one tongue to all humanity, according to the Scriptures. Halleluiah!

However, it is important to point out that in that day, at the breaking up of the building of the tower of babel, God did not break up the family structure, for they needed to understand one another, so that the Commission of reproduction could continue, and that they may refill or replenish the earth. He used a language explosion at the tower of babel to divide them, and He began to move them to the bounds of their habitation, beginning from the days of Peleg. And even when they settled there, with the passage of time, another group were moved out, and they went and settled somewhere else, and out came another nation. And before you knew it, with the passage of time, all nations evolved, and were established in the bounds of their habitation, all around this planet, just as God had Commissioned Adam and Eve, and as He had also Commissioned Noah, Shem, Ham, and Japheth. Yes, I agree, for it is a scriptural fact, and as such, there is no doubt, that in the beginning of the formation of races, most of them married their sisters, half-sisters, cousins, nephews, and what have you, for the beginning of

something always starts small, until it reaches a point sufficient enough for God to break it off. It is like Seth who had to take his sister in marriage, and just like Cain also had to take his half-sister in marriage. It was not incest in the beginning, for God had to start with something! However, as the human population grew up to a point, then God put a stop to it, and the law of incest was introduced, God now creating a genetic law to ensure this, by creating a genetic imbalance in the offspring of incestual relationships. And when the Torah was given, it was laid out in it as part of the laws of Moses. But before this point, Abraham also married his half-sister, as confirmed in Genesis Chapter 20, verse 12, God using the genetic quality of their lineage to brew up a race of people called Israel. And when Jacob and all his children went into Egypt in the reign of Joseph, seventy in number, they also married one another, until a race of people were produced, called the Hebrews. So also, the children of Noah married one another, as they scattered to the four ends of the earth, and as the races continued to evolve. It

did not happen in one day. But as a group of people left a parent group, God used them to form another nation of people, and also God gave them a new language, as language kept evolving by the power of God, eventually establishing the incredible variety of languages we have today on the earth. So also, mutation also continued to work alongside language evolution, until it had reached its terminating point, God having produced all the variety of racial colours of man that He desired to have on earth, before the world was formed. I am showing you Acts Chapter 17, verse 26, in its application! **Everything was predetermined by God, the nations, the time of their national evolution, and precisely where they would be established in the earth, the bounds of their habitation, etc.** However, saints, what started out with just one colour, one racial colour, the Sethite race, God broke up into three in Noah. So in the days of Noah, at the beginning of the second world, our world, the world after the deluge, we now had three races, and out of these three main races of people, we have all other

aces of people. You can read their genealogy in Genesis Chapter 10: The lineage of Shem, the lineage of Ham, and the lineage of Japheth. So out of them, and with the passage of time, mutation produced other varieties of races of men, people having a variety of colors and physical characteristics. Those with a broad nose, like the blacks; those with a sharp pointy nose, like the whites; all sorts of physical characteristics were being introduced, all under God's leadership and timing, the Lord using mutation to accomplish this. Consequently, the foods they ate began to change, based upon their individual environment, and they also started evolving their own cultures and ways of dressing. The way they celebrate marriage in one place, is not the way it is done in another place. (Brother Amos points to the chart). Their way of dressing also began to evolve as well. The dressing of people A, was different to the dressing of people B; and the dressing of people C, was different to that of peoples A and B. We are looking at the evolution of the various nations, out of the three major racial

seeds, which gives us the three sons of Noah. So what do we now have in the earth? It is not just one race of people as at the beginning in Genesis in the days of Lamech, but now, we have various races of people, a great variety of races on God's green earth. Or shall I use the language of the Bible: Now we have **"many peoples"**, and each people or race, all having **"many nations"**, and each nation, having many **"tongues"** or tribes. Brothers and sisters, I am showing you something, and it is this. God takes a race, a major race, and breaks it down into sub-races, giving us a subdivision of races, all by the power of mutation. You have to see that because the Caucasian race, for instance, are not all the same, for to some extent, they differ in physical characteristics. If you look at the Norwegians, for instance, (Brother Amos points to the chart), they have very huge and distinct features. They were the Vikings of old, warriors of those years. When you come to an English man, his physical characteristics and composition is not the same with the Norwegians. And when you come to the Germans, and likewise, the

Russians, or the Eastern Europeans, like the Polish, brothers and sisters, they all have distinct physical features that make them identifiable in the main, for the major Japhetic race is expressed in its sub-races, as God broke down Japheth's racial DNA code, in order to produce the variety in that one race, giving you distinct sub-races of people within the race, all by the workings of God's law of mutation. That is why in their hair type, some are blonde haired, whilst others are brunet; some are wavy, whilst others are straight or curly etc.; some have hair that is jet black, whilst others have light brown hair. The blonde hair is something that the white race seem to love the most though. Let us also take a look at the Hamitic race in the tabernacle of Ham, for another example. When you look at the people of the West African sub-region, the Nigerians, the Togolese, the Ghanians, the Ivorians, etc., they are similar in their physique and skin tone, even though you still have slight variations. Again, when you look at the people of the North African sub-region, the Moroccans, the Algerians, the Tunisians, the Libyans,

the Egyptians, etc., they are similar in their physique, even though you still have slight variations. On the other hand, the people of East Africa, "*the Easties*", as they are called in the United Kingdom, the Sudanese, Ethiopians, Somalians, etc., are very easily distinguishable, having a different and distinct physical features which makes them stand out in all humanity, particularly when placed side by side with the West African people, for Ham's DNA code was also broken down to produce sub-races within that major race, also by the law of mutation. When you even bring that down to the level of "*tongues*" or tribes in the nations, and we take a look at Nigeria as a case study, when you see a Northerner, a Hausa-Fulani, a man from Northern Nigeria, you can tell more often than not, once you know their physical look. When you see an Easterner, an Ibo man, instantly you know him. And when you see a Westerner, a Yoruba man, you will instantly know that he is Yoruba: Because their physical constitution is distinct, bearing the trademark of God's racial divide, at its tribal level! Because it is God

producing this variety in His human flower garden! However, we must not forget that this flower garden was infused with serpentine genes, and this now brings us to the call of Abraham.

In Genesis Chapter 12, we see the call of Abraham, as it is written in verses 1-4: ***"Now the Lord had said unto Abram, Get thee out of thy country, and from thy kindred, and from thy father's house, unto a land that I will shew thee: And I will make of thee A GREAT NATION, and I will bless thee, and make thy name great; and thou shalt be a blessing: And I will bless them that bless thee, and curse him that curseth thee: and in thee shall ALL FAMILIES OF THE EARTH BE BLESSED. So Abram departed, as the Lord had spoken unto him..."***

Saints of God, the Lord wiped away the world in the days of Noah, and started afresh, using the three sons of Noah. A few generations down the road, He called Abraham, whose name was Abram at that material time. So I ask: Why did God call Abraham? What exactly was God going to use Abraham for? Brothers and

sisters, God had a most crucial and divine purpose for calling Abraham. The number one purpose, the first purpose, pertains to the first promise which God gave to Abraham, that He would make him a great nation. One of the major reasons for establishing that nation through Abraham is the reason we first want to lay out. Prior to the flood, Satan had fouled up the genetic nature of the Sethites, the children of God, through interracial marriages, or mixed marriages, and in Noah, the fouling up had come to a close; the cross breeding had come to its head. And that was how the serpent seed crossed over the flood. So all the seeds of Noah had evil serpentine traits in them, every last one of them, for none of them were as genetically pure as Adam, Seth, or Enos, in their DNA. However, in that day, the serpentine gene was more dominant in Ham, and Satan saw that, and he knew that he could use his lineage to introduce idolatry into this world, thereby establishing polytheism, and he did. We have a message in the Scribe which deals with that, and it is titled Genesis: *The Travails of Ham*. But

today as we speak, the Japhetic race have more serpentine traits in them than any other race, which is precisely why they are the race that Satan is using primarily to remove the knowledge of God from humanity, and establish homosexuality in every nation possible. That lets you see that the Japhetic race is in the very shoes of the Hamitic race, back then, for Japheth is to the world, what Ham was in that day. Brothers and sisters, the truth is that none of the children of Noah were pure, for Noah himself was not pure, even though he was a Sethite, a son of God. Noah was no more pure in his genetic makeup than Abraham was, and you all know that Abraham was not a pure Sethite in his genetic constitution, for God called him out of idolatry, something which Adam in his genetic purity did not do! Brothers and sisters, I am trying to paint a picture for you, and that is the fact that all the seeds were already fouled up! And for this reason, amongst other reasons, God did something. He called a man by the name of Abraham. I ask again: What was God's objective? He was going to use that

man to brew up a race of people, because everything had been fouled up through mixed marriages, and God saw something in that lineage, for He saw that Abraham had a genetic quality He could use. What Satan had brewed down through intermarriage, God was going to brew back up through non-intermarriage. You did not hear what I said. Satan bred down the genetic nature of the sons of God through mixed marriages; and God was now going to take the good genetic nature He saw in Abraham; not that he was pure, but that he had a genetic quality about him which God could use. Listen to me now. It is like pouring clean water into something that is defiled, and you keep pouring clean water into it, until it eventually gets rid of the murkiness, and gives you something clean. Is that right? That was God's way of brewing back the genetic attributes of a people He would use to carry something in His plan of redemption, and that is the nation of Israel. I am showing you what God did through Abraham, because God was going to use him, together with his wife Sarah, to produce a race

that would have a genetic quality about them that God was going to preserve; because through that genetic stock, the Messiah was going to come. So God had to watch the gene, and God had to preserve that gene. Now come with me to Deuteronomy Chapter 14, where God warned the children of Israel, as recorded in verse 1, declaring: ***“Ye are the children of the Lord your God: ye shall not cut yourselves, nor make any baldness between your eyes for the dead..”*** Why were they warned not to do this? Verse 2 gives the reason to us, saying: ***“For thou art AN HOLY PEOPLE unto the Lord thy God, and the Lord hath chosen thee to be a peculiar people unto Himself, above all the nations that are upon the earth.”*** The Lord gave the same reason in Deuteronomy Chapter 26, verses 18-19, admonishing the children of Israel: ***“And the Lord hath avouched thee this day to be His peculiar people, as He hath promised thee, and that thou shouldst keep all His Commandments; And to make thee high above all nations which He hath made, in praise, and in name, and in***

honour; and THAT THOU MAYEST BE AN HOLY PEOPLE UNTO THE LORD THY GOD, as He hath spoken.” Now let everyone pay attention to what I now want to say, for it devolves firmly and squarely on mixed marriages, on account of the hybrid product it gives. Brothers and sisters, because the evil gene is dominant, it is an incontestable fact, whether we consider it in the natural or spiritual, that the more something is crossbred, the farther it gets from the original. Moreover, there is nothing that is crossbred that can produce the original; no hybrid can produce the original. There is absolutely nothing that is crossbred or hybridized that has the capacity and the ability to produce or reproduce the original. It ever remains a hybrid, and can never produce an original. As I said before, the more something is crossbred, the farther it gets away from the original. Now please pay attention, because I want to lay something serious, a food for thought. The more something gets away from the original through crossbreeding, the more it loses God's essence which is invested in originals.

Please hear me very well. The more something is crossbred, the farther it gets from the original, and the more it is impossible for it to ever return back to its originality. Furthermore, the farther it gets away from the original, through crossbreeding, the more of God's essence it loses, for the farther away it gets from God. I repeat: **The more something is crossbred, the more of God's essence it loses!** Saints, Bible days are back, and we therefore have the revelation of the whole Word of God, for God has opened up and laid out the entire plan of creation and redemption by His Spirit in this last age. I repeat for emphasis: The more something is crossbred, the more of God's essence it loses! Because in every thorough bred, in every original seed, there is God's essence, a divine attribute of God, and in man, unlike in plants and animals, it is a God consciousness that can be touched and awakened, and which is invested in all original seeds that God has made. In plants and animals, that God essence is what gives them the power and ruggedness they have, the enduring life they have, which hybrid

products do not have! And when you crossbreed it, you begin to lose that divine attribute or essence! Consequently, brothers and sisters, the more human beings interbreed, carrying on with mixed marriages, the farther away from God their products will certainly become, because the more their offspring will lose this God essence: Because it is straying farther and farther away from the original, which is invested with God essence, a God consciousness! Chew on that for a while, for that is most serious! Now we are in deep waters! That is exactly why I said that in an original seed, there is a germ of a new life, just as it is written in the Word of God, for it is the power of a new life which God invests in thoroughbreds. It means in effect, that the more you intermarry with one another, the more likely it is that your seeds are going to get away from God, because they will lose a most vital and necessary essence of God invested in thoroughbreds; because the original life is not invested in hybrid seeds; it is invested solely in original seeds. That is why there are people today, that you cannot even tell where they

come from. I do not know, maybe they come from the moon. I have to say it like that because they are a sorry case, genetically speaking, even though they themselves have no clue. I do not say that to be rude, please! I say that to make a serious point. Mixed race people may be beautiful looking in the flesh; they may be beautiful dusts as women, or handsome dusts as men: But let me warn you now, the fact remains that that beautiful dust, more often than not, cannot truly relate to God in His divine revelation! And the more they interbreed, the farther away they get from God. Yes, they may be business tycoons or mathematical geniuses; they may be top athletes or music maestros; they may be intellectual wizards; they may be computer gurus; they may be able to develop new applications for tablets and mobile phones which may wow the world, and which may make them instant celebrities and billionaires; but make no mistake about it: They will not be able to relate to God in His light, and more often than not, such characters never want anything to do with God, for the very notion or

thought of God, even looks strange to them! Think about that! When you take 99.9% of them, there is nothing in these type of people that can relate to God, and there is nothing in them that makes them want to relate to God, because the God essence is not in them; for it has been watered down through crossbreeding. Yet, in themselves, they may be nice people. However, what is the value of a person being nice when he cannot relate to His Maker? He will just live for a while and then perish, even though he may have the moon, materially speaking, and that will be the end of him, for his wealth and earthly fame, as the Scriptures declare, will not follow him. Then he will have to face his Maker at the White Throne Judgment, and face eternity away from God. What a wasted life! That is why I always say that I do not want long life, and neither do I pray for it. And please do not pray for me for long life. I am not interested in long life. Is it in this horrible evil world that I want to live long? No! I certainly do not want to live long here, in a world where gays and lesbians hold court, and where

presidents of leading nations of the world are praising, applauding, and rewarding them for being moral perverts, for being homosexuals! I do not need long life: All I need is eternal life, and as such, I am not interested in how long I live here; as long as I can find myself in God, through Jesus Christ His Son, I am most content. There is nothing here, and that is why I am only interested in the hereafter, which is eternity with God. And that is what interests every true son and daughter of God. But these mongrels of people, these hybrids, these mixed race people, in the main, have no true respect or love for God. All they care for, and can relate to, are fleshly material things. Now they have landed a probe on a flying comet. They have been chasing that comet for about ten years. And this probe, or whatever they call it, has been flying in space, covering over 500 million miles. And men with their canary brains have been sitting behind computer screens, punching instructions to it via satellite. And why are they even doing it? They want to look for how water came on the planet. So they spend multi-billions of dollars in

that useless exercise, when for nothing, I can tell them where water came from! They think it is comets falling to the earth that is bringing the water. How foolish man is! So they want to look for how water came on the planet. They are very happy that they landed a probe for the first time on a flying comet, mega millions of miles away. Good for them! However, the probe landed on the back part of the comet, and unfortunately, the battery power has run down. So they are forced to put it on sleep mode, and they are rejoicing over that, when millions are going to bed tonight with no food in their stomachs. And if they find out how water really got here, what will they do with that knowledge, when they are not leaving this planet for another one? It will not be done! Saints, when Jesus comes for us bride saints in the sky, it is written that we shall be like him. We are going to be changed in an instant, in the twinkling of an eye, and we are going to be like angels. And in that glorified state, we can push any comet out of the way, and reposition it. Glory to God! Are you listening to me? Brothers and sisters, just a thought, and you are there.

In that blessed and glorious state, Pluto is just a thought away. All we need to do is merely think of it, and we are on Pluto, exploring it. I will say: "*Brother Victor, let us go to Neptune*", and in just one step, we are exploring Neptune, for in that supernatural immortal body, distance is nothing, for we are like angels! That is what the day of rapture holds for us. Think about it! In the resurrection, we are like angels, with great divine power and glory; we become superhuman beings, Immortals! We do not need to catch a flight in order to travel to America. As we are standing here now, we are also seeing the streets of New York without having to Skype. I say that to let you know that in the resurrection, we do not need airplanes and probes. And neither do we need mobile phones, skype, and satellites: All those things are for fallen man. Brothers and sisters, Angel Michael can talk to us right where we are now, directly from where he is over there before the throne of God in heaven, and yet, in another second, he can be beside us! He does not need a mobile phone, for it is fallen man that needs those things. And men pride themselves in their earthly

achievements, achievements which are only for the fallen man. I appreciate the conveniences of life which God has enabled men to make for our comfort, but the fact is that our lives mean much more than those carnal things. And we should be able to relate to our Maker, for He has been so good to us, giving us all these good things of life. But the truth is that when we receive our glorified bodies, we will no longer need mobile phones or skype, for you can see and hear things millions of miles away, and know things that are absolutely impossible for fallen men to know right now! It is fallen human beings that are cracking their brains to work out the formula to talk to something they call aliens up there, aliens that do not exist. Let me get back to my point and close. I appreciate your patience. It has been a joy having you at this Convention. We appreciate the sacrifice you all made to be here, and for the support of our brethren that makes this possible. Your love and stand for truth is invaluable. May God richly bless your souls. Amen.

I was making a serious point, that the more

humanity crossbreed, the more they lose God's essence, and get farther away from God, and the more difficult it is for mixed seeds to relate to their Maker, for they are bred-down seeds; complete hybrids. That was why God chose Abraham, seeing a certain genetic quality in him above all his peers in his lineage, even though he was born into idolatry, as Joshua Chapter 24, verse 2 reveals: **“And Joshua said unto all the people, Thus saith the Lord God of Israel, Your fathers dwelt on the other side of the flood in old time, even Terah, the father of Abraham, and the father of Nachor: AND THEY SERVED OTHER GODS.”** This truth is re-confirmed in verse 14: **“Now therefore fear the Lord, and serve Him in sincerity and in truth: and put away the gods which your fathers served on the other side of the flood, AND IN EGYPT; and serve ye the Lord.”** Grace, sheer grace, was what brought Abraham out. God's plan was this: *“I will use Abraham for the genetic quality that is in him, the state of his soul; and with his wife having the same gene, with them I will start a nation of people, and I will watch over that*

nation.” God was going to brew them back up genetically, and it was a slow process. He would send His Word to them, that they may bear His Word, thereby impregnating them with the prophetic Word of the Messiah. That is why Israel is a peculiar and a holy people unto God. And that is precisely why they are not allowed to mix marry, regardless of how much a Gentile believes. They claim out there that God forbade the children of Israel from entering into mixed marriages because of idolatry, that their unbelieving spouses will lead them into idolatry, and they quote Scriptures as proof; but that is only half of the story, being a half-truth! I want to show you that the reason they were forbidden from mixed marriages, is much more than the issue of idolatry, even though that is one of the main reasons. For the other fundamental reason which church going folks are not considering, please turn with me to the Book of Ezra, Chapter 9. Let me give you the background. The Jews, whilst they were in captivity in Babylon, had married all sorts of people as wives. Now God brought a remnant back to their homeland, to await the

coming Messiah, and we will continue the reading from Ezra Chapter 9, and verse 1: ***“Now when these things were done, the princes came to me, saying, The people of Israel, and the priests, and the Levites, have not separated themselves from the people of the lands, doing according to their abominations, even of the Canaanites, the Hittites, the Perizzites, the Jebusites, the Ammonites, the Moabites, the Egyptians, and the Amorites.”*** In the next verse we are told exactly what they did, what the abomination was. Verse 2 records: ***“For they have taken of their daughters for themselves, and for their sons: SO THAT THE HOLY SEED HAVE MINGLED themselves with the people of those lands: yea, the hand of the princes and rulers hath been chief in this trespass.”*** Verse 3 now states: ***“And when I heard this thing, I rent my garment and my mantle, and plucked off the hair of my head and of my beard, and sat down astonished.”*** Now, a serious issue has been touched upon in this passage of Scripture. When Ezra

heard that the Israelites had engaged in mixed marriages with the Canaanites, the Egyptians, and the people of the land, he tore his clothes and wept profusely! You can read the entire Chapter yourself. The children of Israel who were likewise moved in their hearts cried along with him. The question now is: What did Ezra say? His assessment of the implication of their sinful action tells us the story. He declared that ***“the holy seed”*** HAVE BEEN MINGLED! It was more than a case of idolatry, and in this passage of Scripture, it was not even about idolatry at all, but about the mixing of seeds through interracial marriages! THE HOLY SEED WAS MINGLED! And what was the verdict; what was the solution given? Everybody was told to return their wives, including their children. My! That was serious and still is! Think about it! I know that someone will say: *“But Brother Amos, what about Boaz, who married Ruth, a Moabitess?”* We are still coming to pick up that marriage, for there is no stone that we will leave unturned, the Lord being our helper, and there is no Scripture on this issue that

we will run away from or deny, for the Lord has given us the light of truth. However, in the days of Ezra, what was the solution given to the problem created by the mingling of the holy seed? Ezra Chapter 10, verses 2-3 declares: ***“And Shechaniah the son of Jehiel, one of the sons of Elam, answered and said unto Ezra, We have trespassed against our God, and have taken strange wives of the people of the land: yet now there is hope in Israel concerning this thing. Now therefore let us make a covenant with our God to put away all the wives, and such as are born of them, according to the counsel of my lord, and of those that tremble at the commandment of our God; AND LET IT BE DONE ACCORDING TO THE LAW.”*** They carried this cleansing action out, as hurtful as it no doubt was in that day, for it involved a lot of wives and children. Read the two material Chapters in Ezra! Saints, in this so-called modern day, they would be called barbaric, and they would have taken Ezra to the International Criminal Court in The Hague, Netherlands, for

crimes against humanity, for the great number of families that were broken up. All their wives and all their children were sent packing back to their lands! And they had to do it. Why? You have to see that the issue of mixed marriages is much more than just about idolatry, for we were not told that any of the Jews involved in the mixed marriage relationships in that day were in idolatry, as a result of the mixed marriage! This was about THE MINGLING OF SEEDS, which ought not to be! And there is no doubt that these wives had been truly converted to Judaism, and as such, they were believers in that day! Yet, their conversion to Judaism was not enough in that day! Why? It is simply because THE HOLY SEED HAD TO BE PRESERVED PURE, that is, without mixture! God chose Israel as a peculiar nation unto Himself, and God specially brewed up that nation, because they would be the people He would use to carry His law, which no other nation had; a race of people through whom true Monotheism would be restored to humanity, which is the worship of the one true God, Elohim; not Allah, but Elohim! Moreover,

through that race, the Messiah was to come, and as such, it was most imperative that **“the holy seed”** be preserved in the absolute purity of its originality! IT WAS ABOUT THE PRESERVATION OF THE HOLY SEED OF THE CHILDREN OF ISRAEL! The Book of Deuteronomy Chapter 4, verses 7-8, records: **“For what nation is there so great, who hath God so nigh unto them, as the Lord our God is in all things that we call upon Him for? And what nation is there so great, that hath statutes and judgments so righteous as all this law, which I set before you this day?”** God now adds in verses 32-35 challenging the Israelites: **“For ask now of the days that are past, which were before thee, since the day that God created man upon the earth, and ask from the one side of heaven unto the other, whether there hath been any such thing as this great thing is, or hath been heard like it? Did ever people hear the voice of God speaking out of the midst of the fire, as thou hast heard, and live? Or hath God assayed to go and take him a nation from the**

midst of another nation, by temptations, by signs, and by wonders, and by war, and by a mighty hand, and by a stretched out arm, and by great terrors, according to all that the Lord your God did for you in Egypt before your eyes? Unto thee it was shewed, that thou mightest know that the Lord He is God; there is none else beside Him.”

Church, there is no denying the fact that the Jews are a peculiar people unto God, for God brewed up their genetic constitution, and He wants it preserved. And through that race, all the oracles of God were given, both Old and New Testaments. And not only that, but through them, the true knowledge of the one true God was restored; and further, through that same race of people, Jesus Christ, who is the prophetic seed of Adam, the serpent bruiser, came. Our Lord Jesus came through the race of people God used Abraham and Sarah to brew up, and as such, it was very important that the Jews did not marry into another race. It was and is that important! That was why, ever before Israel became a nation, ever before the patriarchs of the

twelve tribes were born, when it was time for Abraham to get a wife for Isaac, his son, he had enough revelation burning in his heart, to know that there is a particular genetic quality that his lineage has, one which God was using, and as such, he called his chief servant, Eliezer, to go straight there, and from that very kindred, he was to take a wife for Isaac. It is written in Genesis Chapter 24, verses 1-4: ***“And Abraham was old, and well stricken in age: and the Lord had blessed Abraham in all things. And Abraham said unto his eldest servant of his house, that ruled over all that he had, Put, I pray thee, thy hand under my thigh: And I will make thee swear by the Lord, the God of heaven, and the God of the earth, that thou shalt not take a wife unto my son of the daughters of the Canaanites, among whom I dwell: But thou shalt go unto my country, and TO MY KINDRED, and take a wife unto my son Isaac.”*** He said this by divine revelation, for as it is also written, that Abraham was a friend of God, who had the secrets of God's working! God is the beginning, the genesis of

Israel, and He is also her ending glory! So Eliezer went and got Rebecca, and Isaac married her. Brothers and sisters, what a revelation Rebecca also bore: Because she had the mind of God, and knew that of the two seeds struggling in her womb at pregnancy, Jacob, the younger, not Esau, was the appointed seed of God, even though Esau was the first born! This revelation made her watch over Jacob like a hawk, and she taught Jacob what to do to get the inheritance. Saints, some people have walked with God! My, oh my! May God help me! May God help us all! Moreover, when it was time for Jacob to also get a wife, as recorded in Genesis Chapter 28, Isaac sent him back to his kindred, his father-in-law's family, of the same racial stock, on account of the DNA gene carried by that lineage, as verse 1-5 now reveals: ***“And Isaac called Jacob, and blessed him, and charged him, and said unto him, Thou shalt not take a wife of the daughters of Canaan. Arise, go to Padanaram, to the house of Bethuel thy mother's father; and take thee a wife from thence of the daughters of Laban thy mother's***

brother. And God Almighty bless thee, and make thee fruitful, and multiply thee, that thou mayest be a multitude of people; And give thee the blessing of Abraham, to thee, and to thy seed with thee; that thou mayest inherit the land wherein thou art a stranger, which God gave unto Abraham. And Isaac sent away Jacob: and he went to Padanaram unto Laban, son of Bethuel the Syrian, the brother of Rebekah, Jacob's and Esau's mother.” You have to see something, genetically speaking! Come on! And what a revelation ruled the lives of these precious sages of old! My! God was in everything concerning the brewing up, and the establishment of the nation of Israel. I am just showing you something, for it is definite that the issue we are treating today, goes beyond the issue of idolatry or being an unbeliever! It is about the preservation of a genetic quality in a race of people that God was brewing up, that they may have a better DNA code! Wake up! And let me tell you tonight: In all the nations of the world, speaking in the natural, there is no nation like the

nation of Israel; and of all races of people on this planet, there is no race like the race of Israel, naturally speaking. There are no people like the Jews on this planet, speaking in the natural! Look at these Jews. (Brother Amos points to the chart). From the time they are young, as little boys, they are taught the Torah, and they are taught to serve the Lord God with fear, for God and His Word is the very centre of the nation of Israel. I am not talking of modern Israel, but of the Israel back then! For at the moment, they have been temporarily shut out of the plan of redemption; but their visitation, their revival, is coming at the opening of the 70th Week of Daniel. Saints of God, there is something about Israel and God! That is why Ezra cried, just as the Bible declares, that **“THE HOLY SEED have mingled themselves with the people of those lands.”** It is about the seed! It is more than the issue of idolatry; it is also about the seed! Brothers and sisters, everything is by revelation, for we are not expected as bride saints to carry the mere letter of the Word, for the true light of the Christ of the Bible is now shining

marvelously at this evening time, just as God promised through Prophet Zechariah. And all God needs to start the rearing of many seeds, whether of birds, animals, or man, is just one pair of original seeds, male and female, just as He started in the beginning with only Adam and Eve, and as He also later started with Shem, Ham, and Japheth. And look at what God has produced today in the earth, the incredible variety and diversity of His human family, which He is now taking through the process of redemption! Despite the fall, the Lord still produced to Himself His most beautiful, diversified, and colourful human flower garden, which He foreordained to have before the foundation of the world, except that He is now bringing them back to Himself through the process of redemption, a process which is now slowly being wound up to a close, for it is obvious that Jesus Christ is coming soon.

Brothers and sisters, when we consider this lovely variety that God has in His human flower garden, an incredible racial and national diversity, out of

which God received seeds to Himself, through a glorious process of redemption, do you know the revelation Apostle Peter has concerning the redeemed flower garden of God? Come with me to the Book of 1 Peter Chapter 2, verse 9, which declares: **“But ye are a chosen generation, a royal priesthood, AN HOLY NATION”** (of a universal body of people, the nation of the bride of Christ, a people called out of every race and colour, out of every nation, and out of every tribe on this earth), **“A PECULIAR PEOPLE”**, (just as natural Israel is to God); **“that ye should shew forth the praises of Him who hath called you out of darkness into his marvellous light.”** Brothers and sisters, here is the nation of the universal bride before you, a body which is typed by the natural nation of Israel, referred to in Acts Chapter 7, verse 38, as **“the church in the wilderness.”** So, yes, it is written in the New Testament Scriptures, that the body of Christ is one, (for it is one mystical body, where there is no male or female, no Jew or Gentile), yet, we must not also forget that in that body, which is a

universal body, we have all races of people, all nations, and all tribes, being a diversified and distinct multi-racial and a multi-coloured people, for the bride of Christ, which is one body, is also made up of **“many members”**, MANY RACIAL AND NATIONAL MEMBERS, which gives us what the end time Elijah-Star Messenger called God's human **“flower garden.”** Think about that! I am simply reminding you this morning, that the one body of Christ, is composed of, or made up of the elect people of God from all the different races and nationalities God has produced on this planet, through natural reproduction. Please bear with me. I appreciate your patience. Look at it. Out of this body came all races and colours of people. Do not worry about the paint on the faces of some of the people I used in the chart. Simply ignore that. (Brother Amos points to the chart). I used these pictures just to show you the various nations and races of people. Brothers and sisters, these are Nigerians in this photo in their national regalia. (Brother Amos points to the chart). That is a Ghanaian couple in their national

regalia. When you see a Ghanaian, you know that it is a Ghanaian. The **“Kente”** material and the way they wear it gives them away. The form of dressing here also shows that this is a Nigerian couple. And that is an Ethiopian couple over there, with a Somalian couple right next to them on the left. (Brother Amos points to the chart). Right here we have an Algerian couple. Brothers and sisters, the Nigerians, the Ghanaians, the Ethiopians, the Somalians, and the Algerians, are all children of Ham, but yet, they have different skin colours, because they make up three of the racial subdivisions within the race of Ham, all within the Continent of Ham, which the Bible called **“the tabernacle of Ham.”** Next, we have the Jews. Look at the Europeans here. The people in the photo here look like British families. Here we have a Japanese family with their **“Kimono”** apparel; and next to them we have the Chinese with their national regalia. Next to them we have an Indian family, followed by a Mexican family. Finally on our chart, we have a Malayan couple, which gives us the Malaysians, as well as the Indonesians,

which is the last racial photo we have on our chart. Do you know church, that there is no nation of people on this earth, out of which God has not given to Himself natural seeds, who have been redeemed to make up a part of the universal bride of Christ? As we stated much earlier, a lot of nations may not make up the bride of Christ ordained for today; but at one period of time in this grace age, they have supplied God with an element of bride saints: Arabia, Iran, Egypt, Libya, Turkey, and Syria inclusive, amongst many other nations, who today, in this last age, and particularly in this last move for the Gentile bride, will not supply even one lone seed as bride. Whatever you read in the Scriptures, please do not forget that the bride of Christ is coming out of all nations, in the resurrection, when we go in the rapture. That is why when Brother Branham was given a prophetic preview of the universal bride, he saw the bride saints dressed in their national garb, national dress. Before him passed the Asian church, the American church, that of Switzerland, Germany, Sweden, India, all races of

people, all in their national garbs, but all cleanly and properly dressed, for none exposed their tummies, or belly buttons, or breasts! They were decently clothed! The divine prophetic projection of the different races and nations of people in that vision is because even though the bride is one body, it is made up of many different races and nations, different varieties of people on this planet, who together make up the one human family of God, a human family who have also gone through the process of redemption back to God. All nations of people make up the bride of Christ. In the Book of Acts, Chapter 15, when the issue of circumcision caused a heated contention among the Gentiles, and the matter was referred to the apostles in Jerusalem, Saint James stood up in the conference, and declared in verses 13-17: ***“And after they had held their peace, James answered, saying, Men and brethren, hearken unto me: Simeon hath declared how God at the first did visit the Gentiles, to take out of them a people for his name. And to this agree the words of the prophets; as it is written, After this I will return, and***

will build again the tabernacle of David, which is fallen down; and I will build again the ruins thereof, and I will set it up: That the residue of men might seek after the Lord, AND ALL THE GENTILES, upon whom my name is called, saith the Lord, who doeth all these things.” Did you hear what Apostle James said? He said that God has ordained to take out from among all the Gentile races and nations, an elect people to bear His salvation revelation! This fulfils the promise of God to Abraham in Genesis Chapter 12, verse 3, that through him, ***“ALL FAMILIES”*** or ALL NATIONS ***“of the earth”*** WILL ***“be blessed”*** salvationally, as confirmed by Apostle Paul in Galatians Chapter 3, ***verses 13 - 14!*** Consequently, we must understand that God's salvation blessing does not take away our racial or national identities, for it is a salvation which preserves our distinct racial and national identities, fulfilling the promise that salvation will be given to elect seeds of God out of ALL races and nations of people on this earth. Now tell me just how that will work with racial

mixing, or mixed marriages, which takes out racial and national distinction? Chew on that! There will be no distinct races and nations of people to be saved, IF mixed marriages creates a giant cesspool, a great mongrelizing, or a great hybridization of the peoples of the earth! In that body there will be Germans, French, British, Russians, from Europe, genetically speaking, or racially speaking. There will be Japanese, Chinese, Filipinos all these nations of people we have in the Orient, Far East Asia, including the Indians, genetically speaking, or racially speaking. There will be Brazilians, Argentinians, Chileans, from South America, genetically speaking, or racially speaking. We will have Mexicans, Americans and Canadians, from North America, genetically speaking, or racially speaking. We will also have Egyptians, Nigerians, Ghanaians, Togolese, and South Africans, from Africa, amongst all other nations, also genetically speaking, or racially speaking. So, I ask again: How then can you mix them all up through mixed marriages, and still have the different and

distinct peoples or races of the world, making up God's universal bride, as God promised Abraham? Church, if **“the Scripture cannot be broken”**, and we know it certainly cannot, then, common sense will let you know that God will not allow the devil to mix up everything through interracial marriages, until there are no people that make up these diversified and distinct races of people, sub-races of people, and nationalities, out of which the universal bride is constituted! If we begin to mix marry, we will begin to whittle down God's objective to have in the bride, the distinct races and distinct nations of people! That is why I am crying, that this issue is not about salvation. And when I say that, I mean that it is not about being saved; but as believers there is a fundamental truth of God that you must see: You must see THE ETERNAL OBJECTIVE GOD HAS FOR HIS NATURAL CREATION, HIS HUMAN CREATION, IN RELATION TO REDEMPTION, for it also borders on redemption, with respect to those who make up God's redeemed family. After all, the issue of salvation came only

because man fell. But if man had not fallen, the objective of God for natural human creation would still have remained, fulfilling the C o m m i s s i o n o f reproduction, because God wanted to have different races of people that will make up His human family. You have to see that! And inspite of the fall, that objective remained, and has been realized, except that these same elect people are now being redeemed. Therefore, redemption does not take away their racial and national identity. It cannot be plainer, and if you still cannot see it, then I cannot help you. Pray to God!

Now I need to strike a balance, for we cannot take a truth into extremes. Indeed, we cannot take any truth into extremes. We all know that the peoples of this world are readily and easily identified by their p h y s i c a l g e n e t i c constitution, which are their physical features and the colour of their skin; their dressing; their culture; their food, and so on. Consequently, if a Nigerian, for instance, being a black brother, marries a white sister, because the white sister is also a believer, their offspring will be mixed

race, “mulatto.” And if this trend should continue, give it time: There will be no distinct races of people anymore on this planet, and that will just defeat God's plan of human reproduction, God's plan of creation. It will be nothing but a mess that Satan has created, a racial cesspool of the devil. However, and please listen well, and you will have to agree with me on this, if a black man marries a black lady from somewhere else, their offspring is not going to be any different, because the reproduction is by black with black. Again, if a white brother marries a white sister from another nationality, because both are white, their offspring will also be white, for he will not be any different, because the reproduction is by white with white. But let us now come down a little, and look at racial subdivisions. Let us take a typical example. Look at the case of this man here. (Brother Amos points to the chart).The man is Nigerian, but the lady, his wife, is Indian. Let us assume that they are both believers, merely for the sake of illustration. We know that the Indians and the Nigerians are all children of Ham. It does not matter what anybody wants

to claim; the fact is that we are all children of Ham, particularly when we consider South India. Are you listening to me? So we say this: Well, since we are all believers, we should be able to marry one another as fellow children of Ham. Well, the problem with that is that the Nigerians, or the West African race of people, are very different from the Indian race, for you are looking at two different branches of the same tree. That is the problem, for we are speaking now of sub-races! Remember the West African race are from the same genetic stock. So there is not much of a difference in our physical look and characteristics. We all look alike. Are you with me? Because we come from the same genetic branch or subdivision. The tone of our skin, our hair type, and our physical features, show this out plainly. It is evident that the progenitor of the West Africans is one. And as I stated earlier, the physical characteristics of the West Africans is not the same as the East Africans, for they come from another stock or branch of Ham. When you see an East African, you can tell, just as you can tell a West African,

whether male or female. And when you go to North Africa, Algeria, Egypt, Libya, Tunisia, the hair of the women are very long, and the people are also fair skinned; whereas the people of West Africa are dark skinned, and the hair of our women are short and kinky. That is our hair type. It is short and hard to manage. Brothers and sisters, I am making a point, for although the West Africans, the East Africans, and the North Africans, with the South Africans, are all Hamitic in their racial origin, yet, they are different in their sub-racial division, and hence, the genetic constitution they have, which the law of mutation produced in them, is not the same, for even within Africa, there is a great variety of peoples and colours. Consequently, brothers and sisters, I will not encourage marriage with different sub-races, because it will produce a mixed race child, if for instance, an Egyptian marries a Ghanaian. I will certainly not counsel a West African sister or brother, to take a North African brother or sister in marriage, for it will show! And as I said before, we are different in colour and physical features to a

degree, and our cultures are also different; and so you are going to have problems, social problems, in your marriage, because the food is different, the dressing is different, the customs or culture is different, and the language is certainly different. Are you listening to me? Yet we are all believers. But if a Ghanaian or Togolese marries a Nigerian, and you produce your child, nobody will ask you: *“Brother, where did you get this child from?”* Nobody is going to ask you that, because he will have the physique and colour similar to the people of the region, except you will have some language problem, and hence, some social problems. But if a West African now marries an Indian, because the Indians are also children of Ham, your offspring will certainly show that you have entered into a mixed marriage! Are you listening to me? And there are many problems with mixed marriages. You will have a great deal of social conditions to contend with. The people of the two countries would not like it, and you will have a lot of antagonism because of it; and people on both sides, though they may not have a choice but to accept it, they

may not like it either, and your children are going to face resentment from people. You are certainly going to have social problems, for you will face a language barrier, much culture shock, and differences in food and dressing. Moreover, your offspring will not be able to relate to anything, because they are neither here nor there, being mixed race. Therefore we must understand that although we are all children of Ham as Africans, we have sub-races within this major racial tree, for we certainly have subdivision of races. On the other hand, if an Indian brother or sister marries a Pakistan, Sri-Lankan, or Bangladeshi, that will be okay, because they form one sub-racial bloc, and they are genetically one, even though they do not like one another. But nevertheless, they are all from one racial branch or stock, just as the West Africans have one progenitor as well. Mahatma Gandhi of India recognized this fact, and he tried all his best to keep them all together, and he was assassinated in public by his own people for this very reason, for they wanted to go their separate ways, constituting different

nationalities! As long as they fought the British Imperialists, they were one. But after they won independence, they wanted to go their separate ways, and hence, they killed Mahatma Gandhi. His killer, Nathuram Vinayak Godse, was a militant Hindu nationalist organizer in India. However, of a truth, the marital product between an Indian and a Pakistani would not be any different, for the people look the same anyway, for they come from the same sub-racial stock! And since we are on this subject, let me also touch upon marriage between an African black and an African-American, and close. We will finish off this message in my next meeting. We all know that African-Americans are all Africans by racial origin, for their forefathers were taken away by force from West Africa into slavery, to work on sugarcane and cotton plantations in America. Their DNA genetic code is therefore African, and hence the reason they have the same complexion and physique with Africans. Consequently, if a brother or a sister from the United States wants to marry a believing person from Nigeria, I will not find

anything wrong with it, for it will be alright, for they belong to the same sub-racial bloc; except you will have social problems. The truth is this: Being an American, having been born and bred in a nation that has everything, and they have it so cheaply and readily, until they have become a nation of wasters, he or she will find it very difficult to adapt to life in Nigeria, for instance, where the basic amenities of life, which they take for granted in the West, like constant electricity, running water, good roads, cheap food, and shopping malls, etc., does not exist. Consequently, the marriage will suffer a lot of strain and stress, and the hardship may be too much to bear, thereby negatively affecting the marriage. However, if they have the money to buy fuel, and to also maintain an electric generator, and acquire decent accommodation, provide good food, then the marriage may work! I say that because things are not the same in Africa, as it is in the United States. That is a fact! But let me warn, and I say this only because of the opposition, who are not interested in any truth that has been well laid out in this message, but are only

interested in what they can get to tear down the truth. When I talked about marriage between people of the same sub-racial bloc, please note that that is not stated as something that the saints are to embark upon as a matter of marital policy, for we must be ruled by the Scriptures; for God has a standard picture we must all uphold and live by. Hence, what I stated was not stated for general application by the body of saints, for that will tear down God's objective for human creation, God's human flower garden. However, I have had to say that only in order to give opportunity to an extremely few and insignificant number of saints, who are single, and who are finding it very difficult to find a spouse in their country, because of the lack of believers of the message of life, a harsh reality which some brethren are facing as we speak, in certain countries! A hand of mercy has to be extended to such brethren, if we are not to be like the Scribes and Pharisees whom Jesus condemned in Matthew Chapter 23, and of whom the Lord stated in verse 4: **"For they bind HEAVY BURDENS AND**

GRIEVOUS TO BE BORNE, and lay them on men's shoulders; but they themselves will not move them with one of their fingers." Think about it! What are the brethren, who do not have any body of saints believing the Message of life in their country, to do? Take on stark unbelievers? I think not; for God is merciful, and He knows our true state! Moreover, we cannot take a truth, indeed, any truth, into extremes, for this is not stated to tear down the truth of the Word of God concerning the different and distinct races and nations of people! But even in the Word of God, the Lord Himself makes exceptions in special cases! We are looking strictly at isolated cases, and not a general trend; otherwise I will ask you: What are you going to do with Ruth, the widow of Mahlon, Naomi's first son, whom God admitted into the commonwealth of the nation of Israel? Come on! It is by this same exception in an unusual situation, that the Moabites and the Ammonites were produced, as revealed in Genesis Chapter 19, verses 29-38! Crack that bone! Yes, we know that

these are exceptions that God made. But the case of the daughters of Lot in this passage, lets us see that God will always extend His hands of mercy to His children in unusual or difficult situations! That is a fact! What a good God we serve, and how loving He is! May His glorious name be praised forever and ever, Amen!

Brothers and sisters, God does not want us to destroy His human flower garden, on the premise that it is a marriage between two believing children of God. We just cannot use the law of equal yoking required in 2 Corinthians Chapter 6, to take out God's law of procreation laid out in Genesis Chapter 1, verses 11-12, for they are both truths of God, and both have their application.
